1.0 Recommendations for decision/noting:

It is recommended that the Boundary Review Committee:-

- 1.1 Approves the relocations of Polling Places and redesignation of Polling Districts as set out in this report and at Appendix 1, amending the electoral register from 1 February 2023 to take effect from the local elections to be held on 4 May 2023
- 1.2 Delegates authority to the Returning Officer to make further changes to Polling Places/Polling Stations that may occur before the elections on 4 May 2023. This includes making changes to any Polling Place for any reason should it become necessary for the purpose of holding elections across the Borough.

2.0 **Purpose of Report**

2.1 To review polling places, polling districts and polling stations following the Borough Boundary Review completed in 2022 by the Local Government Boundary Commission for England (LGBCE).

3.0 Background

- 3.1 Following a lengthy process carried out by the Local Government Boundary Commission for England, the legal order making changes to the Borough's electoral arrangments was made final by parliament in January 2023. This Order makes changes to the ward boundaries within the Borough which will come in to force at the Borough and Parish elections on 4 May 2023.
- 3.2 The LGBCE review made final proposals for the Borough to retain 54 councillors made up of 32 wards (an increase from the current 30 wards). This consists of 5 x three councillor wards, 12 x two councillor wards and 15 x one councillor wards. The boundaries of most existing wards were changed. The review also made recommendations for changes to the warding arrangements for a number of Parish/Town councils as a result of the revised Borough boundaries. - 3.3 In preparation for the new ward boundaries coming in to effect it is necessary that an interim review of polling districts, places and stations be undertaken. For ease, the description of each of these is set out below:-

Polling Districts

These are the sub-areas into which each ward is divided. Most wards will have several polling districts within them and, wherever possible, it is considered good practice for each polling district to be serviced by its own polling station.

Polling Places

These are the buildings inside which polling stations are located. In some cases, the entire building will be a polling place)for example, a portacabin unit). In other cases, only part of the building will be the polling station (for example, a designated room within a school or community use building).

Polling Stations

These are the spaces inside each building at which voters cast their votes.

The last statutory review of Polling Districts, Places and Stations took place in 2019. The procedure for a review is laid down in the Representation of the People Act 1983. The Act lays down how reviews should be approached. The review should ensure that all electors shall have as reasonable facilities for voting as practicable and that all polling places should be accessible by electors with disabilities. Every Parish should be in its own polling district and a polling place should be designated for each polling district.

3.4 The Council is fortunate that most of its polling stations are well established and meet the Electoral Commission's guidelines for polling stations. Due to the ongoing support from the wider community the Council only uses a small number of temporary portacabin style buildings and also uses a very small number of schools.

- 3.5 The consultation period began in late October and closed on 30 December 2022. Ward and polling district maps and a Borough wide map were provided on the Council's website to assist residents in identifying their proposed polling station.

 This information was circulated to all Borough councillors, to Parish Councils and to both Members of Parliament for the area. To assist with consultation, the support of the Council's Community Engagement team was sought in order to reach out to a wider audience. In addition, officers worked with representatives from the Council's Making it Real Board to look at polling station accessibility for residents and in particular access for people with disabilities.
- 3.6 A review of proposed polling stations was undertaken to assess accessibility requirements and to assess requirements resulting from Voter ID requirements contained within the Elections Act. Additionally, the Electoral Commission has issued guidance for Returning Officers on assistance with voting for persons with disabilities. 4.0 Summary of main proposals

4.1 In view of the wide ranging changes made by LGBCE a number of electors will vote in different wards on 4 May 2023. A number of electors may also be voting at a different polling station, dependent on the outcome of this review. A number of polling districts have been merged following boundary changes whilst some polling districts have been split to accommodate changes and warding of Parish areas. Affected electors will be notified of any change to their polling station on their polling cards prior to elections in May. The Returning Officer's proposals for each ward are shown below.

Admaston & Bratton

Electors move in to the ward from the Crowdale Road area of the Shawbirch (WSH) ward. A new polling district (WAB) is required for these electors who will vote in Admaston & Bratton borough ward and the Meadows ward of Wellington Town Council. It is proposed that they continue to vote at Admaston Community Centre

5.1 No alternative options have been considered as this is a statutory requirement for the Council under the Representation of the People Act 1983 to ensure appropriate voting arrangements are in place for residents within the Borough in regard to polling districts and polling stations.

6.0 Key Risks

- 6.1 The key risk associated with any review of polling districts, places and stations is voter confusion and/or voter disenfranchisement. The consultation undertaken in respect of these changes helps to mitigate these risks. In addition, every registered elector who has a change of polling station will be notified of these changes on their poll cards when issued. The council is also exploring the option of writing to every household in the Borough to:
 - a) encourage registration;
 - b) notify changes to polling stations; and
 - c) notify of the need for photographic ID following changes introduced by the Elections Act.

7.0 Council Priorities

7.1 This review furthers the Council's priority to be a community focussed, innovative council providing efficient, effective and quality services.

8.0 Financial Implications

8.1 The costs of this review will be met from existing budgets.

9.0 Legal and HR Implications

- 9.1 The Boundary Review Committee has delegated authority to deal with all matters relating to polling places, polling districts and polling stations. It is a legal requirement for the Council to ensure that it is fully prepared to deliver elections on the new boundaries.
- 9.2 The Returning Officer retains power to make changes to Polling Districts, Places and Stations as needed to ensure elections are conducted effectively.

11.0 Health, Social and Economic Implications

11.1 There are no health, social or economic implications arising from this report.

12.0 Equality and Diversity Implications

- 12.1 The review is required to ensure all electors have reasonable facilities for voting and that every polling place is accessible for people who are disabled. As part of the identification process for suitable venues, Telford & Wrekin Council's Making it Real Board has been consulted and their views considered in this review.
- 12.2 Wider consultation has also taken place which enables views to be taken into account from residents, councillors and community groups within the Borough.

- Ercall ward Proposal to move from Sir John Bayley Club to Red Lion Annex

 responses received from three Wellington Town councillors and one Hadley &
 Leegomery parish councillor
- a. "I'm a Wellington councillor so I have to declare an interest and the previous polling station was at a relatives function room. I felt it was a more central location in the ward."
- b. "The moving of the Ercall ward polling station from the Red Lion on Holyhead road to the Bailey Club on Haygate Road is not very helpful to the elderly or disabled voter with mobility issues. The Red Lions access is much more disabled friendly than the Baily Club, it is also more visible within the ward, and has been used historically as a polling station. The car park is easier to find and access to the polling station is via a ramp not steps

So, I think the residents of the ward would be happier and safer if the polling station was at the Red Lion."

c. "The Polling station for Ercall Ward was in recent years moved from the Red Lion on Holyhead Road Wellington to The Bayley Club in Haygate Road.

The Bayley Club is more difficult for people with poor mobility, they have to walk further, there are steps and parking is not so convenient. Many older residents are not familiar with this location, and the car park is not obvious from the main road.

The Red Lion is clearly seen from the main road, and has easy disabled access, familiar to voters and it would be more convenient for voters to go back to the Red Lion to vote."

d. "The polling station for Ercall ward has previously been located at the Red Lion on Holyhead Road. It is proposed to move the polling station to the Bailey Club.

The Red Lion is more centrally located but more importantly, is located closer to the majority of the elderly population of the ward. Moving the polling station to the Bailey Club will serve to disenfranchise many of the voters who live off Holyhead Road who are disproportionately more likely to suffer mobility issues.

I believe the interests of the electors of Ercall ward would be best served by retaining the polling station at the Red Lion."

<u>4.</u> <u>Ercall Magna ward – Proposal that Eyton electors vote at St Lawrence C of E</u> school, Preston rather than at Kynnersley Village Hall

"On behalf of Eyton Parish Meeting I would like to respond to the consultation on polling stations for the Parish.

The current arrangements are unsuitable. The Polling Station for the Parish is at Kynnersley Village Hall. This is 5 miles away from Eyton Village, where most electors live, and is therefore a 10 mile round trip. It may look on the map as if there is a road over the moors from Eyton to Kynnersley, but that is a private road with locked gates so not passable. In order to get to Kynnersley Village Hall we have to drive through Preston on the Weald Moors and past the polling station at Preston, which would be better as it is 1 mile closer to all electors.

I understand that Shawbirch is in a different ward to Eyton, but the polling station at Shawbirch would be much closer for electors in the Parish."
