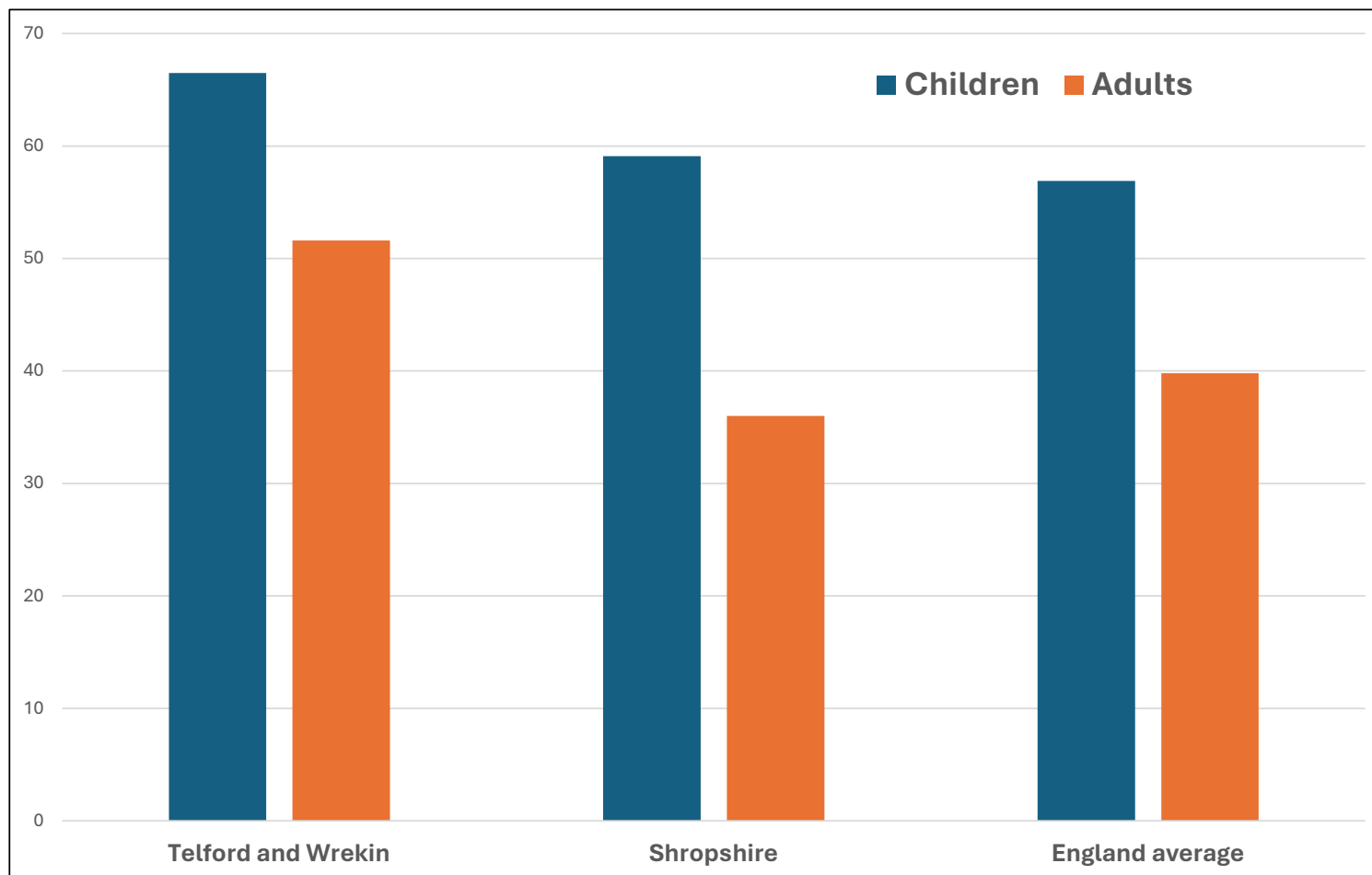
NHS Dental performance and access in Telford and Wrekin

November 2025

NHS dental targets summary

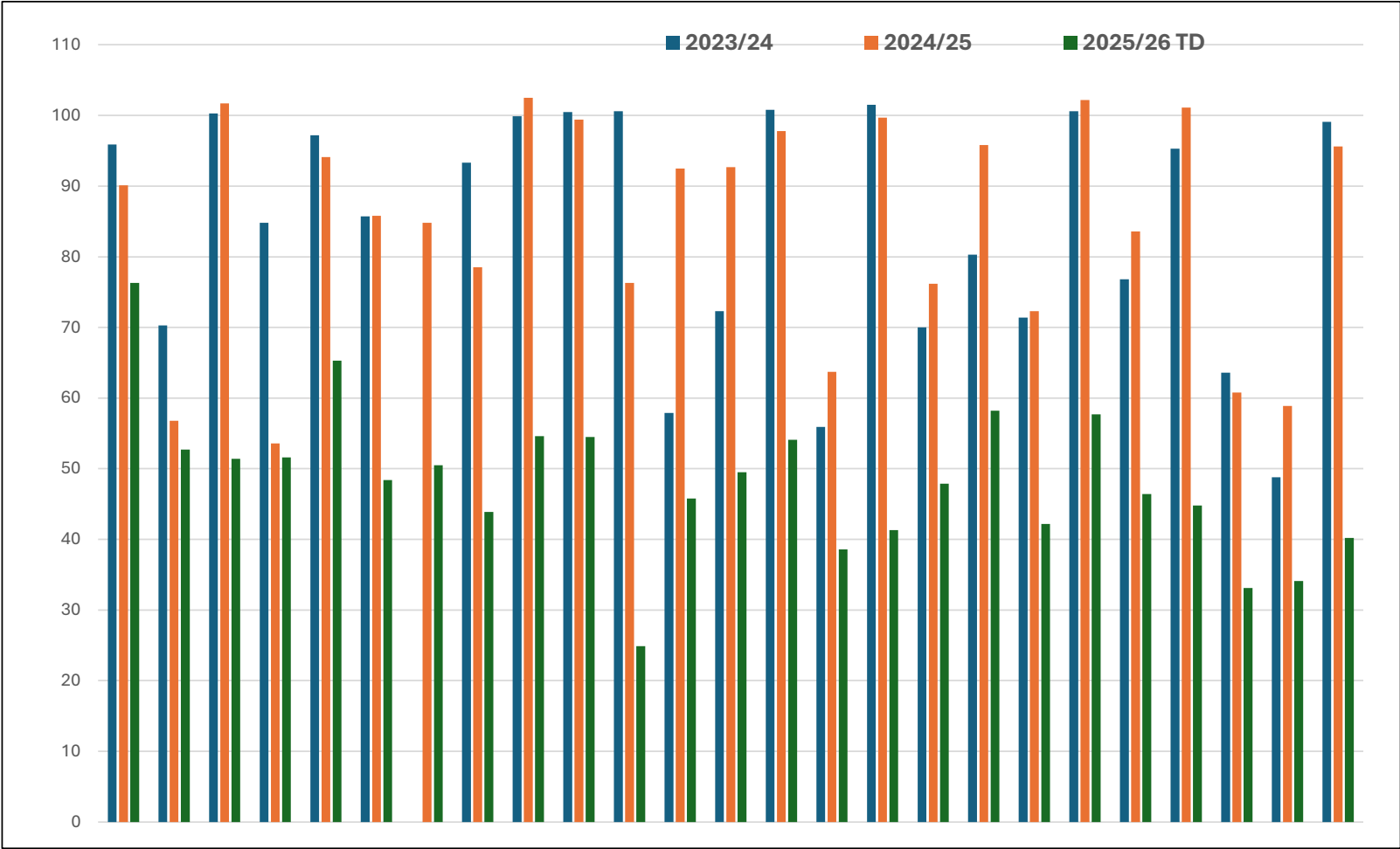
- **Urgent dental appointments** - To meet our proportion of the extra 700,000 urgent dental appointments pledged by the government – this equates to an extra 7,408 appointments on top of the 30,019 already offered across Shropshire, Telford & Wrekin (STW) – an increase of 24.7% in 2025/26
- **NHS dental contracts** - Each NHS dental practice holds a contract for Units of Dental Activity (UDAs) which is monitored on a monthly basis. Across STW as a whole, nearly 800,000 UDAs are commissioned on our behalf by the Office for West Midlands (OWM) which is the regional commissioning model used across the whole of the country.
- **Local investment plan** - In some months in 2025-26 our activity levels have dropped well below the 96% expectation and this has led to an investment plan being produced that will increase funding designed to stimulate activity in areas of need in STW

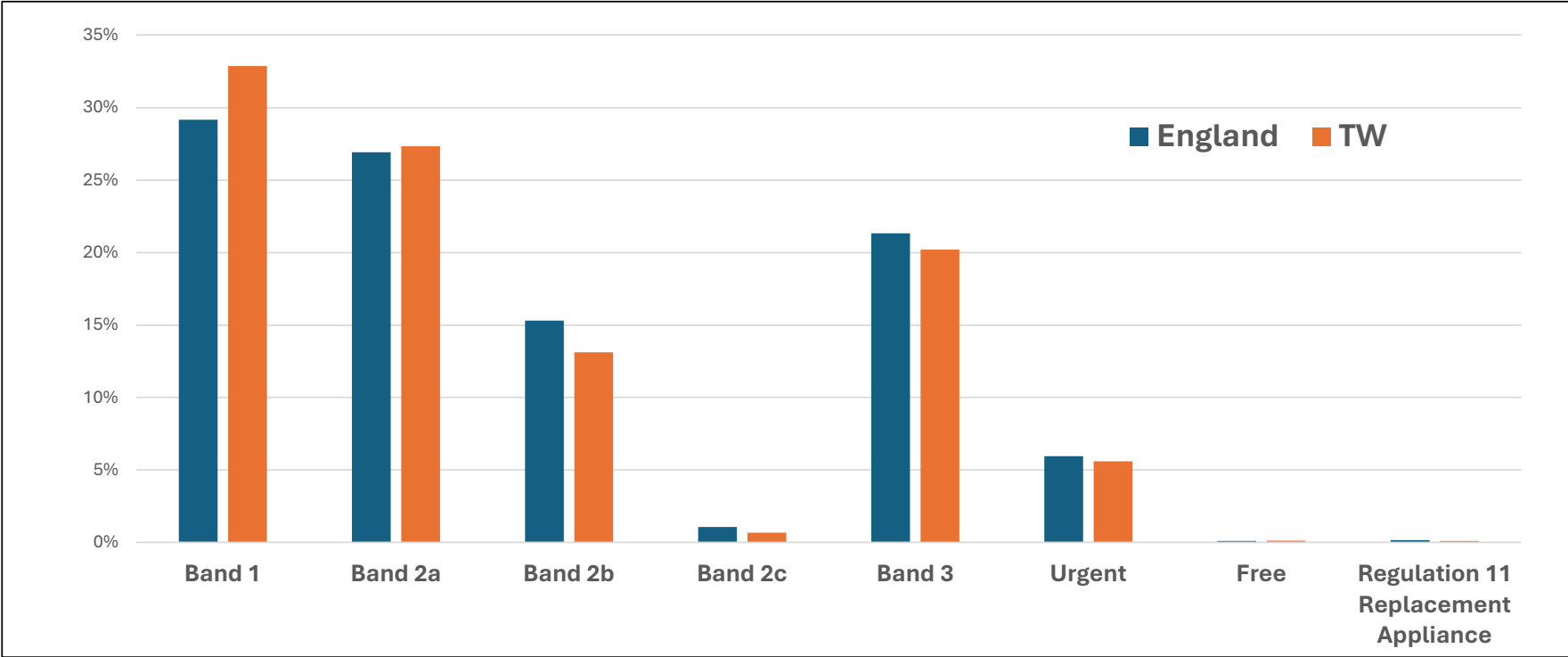
Performance of the 25 dental practices in TW against NHS contracted activity – percentage delivered 2023-24, 2024-25, 2025-26 to month 7



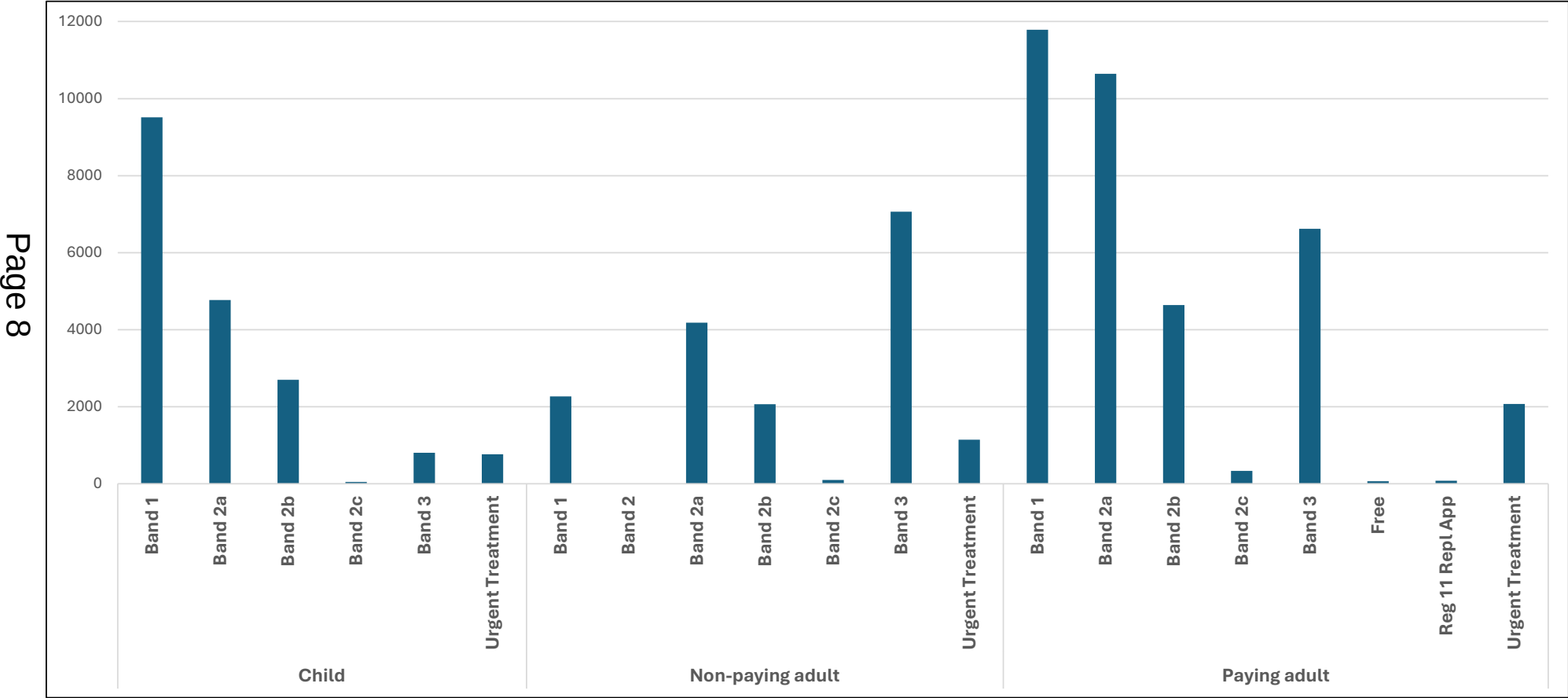
Many practices failed to reach the expected 96% threshold in past years, whilst others overperformed – overall TW reached 96% due to large practices delivering their activity. Overall delivery at month 6 of this year is 47% of total contracted activity, although contracts are phased to deliver more activity later in the financial year, this is a concern an investment plan has been produced

- **Unit of dental activity (UDA)** - A UDA is awarded after the dentist submits a valid FP17 claim form. For example, a course of treatment (COT) of band 2a will generally be awarded 3 UDA
- **Children or Adults** – in the data children are those aged under 18
- **Treatment band** - NHS dental activity is broken down into treatment bands based on how complex the treatment is. NHS dental price bands from April 2025 –

Band	Cost	What it includes
Band 1	£27.40	An examination, diagnosis, and advice. Also includes a scale and polish if clinically needed, X-rays, and the application of fluoride varnish or fissure sealant.
Band 2	£75.30	All treatment included in Band 1, plus additional treatments such as fillings, root canal treatment, and removing teeth (extractions).
Band 3	£326.70	All treatment included in Bands 1 and 2, plus more complex procedures like crowns, dentures, and bridges.
Emergency	£27.40	Emergency care, such as providing a temporary filling or emergency pain relief.

- **Regulation 11 replacement dental appliance** - a replacement for a lost or broken NHS denture, bridge or orthodontic appliance and are charged at £95.70 per appliance

- Expansion of the Shropshire & Staffordshire Oral Health Improvement Team, hosted by Shropshire Community Healthcare NHS Trust, to undertake more targeted preventative work
- Dental Checks in Special Educational Settings

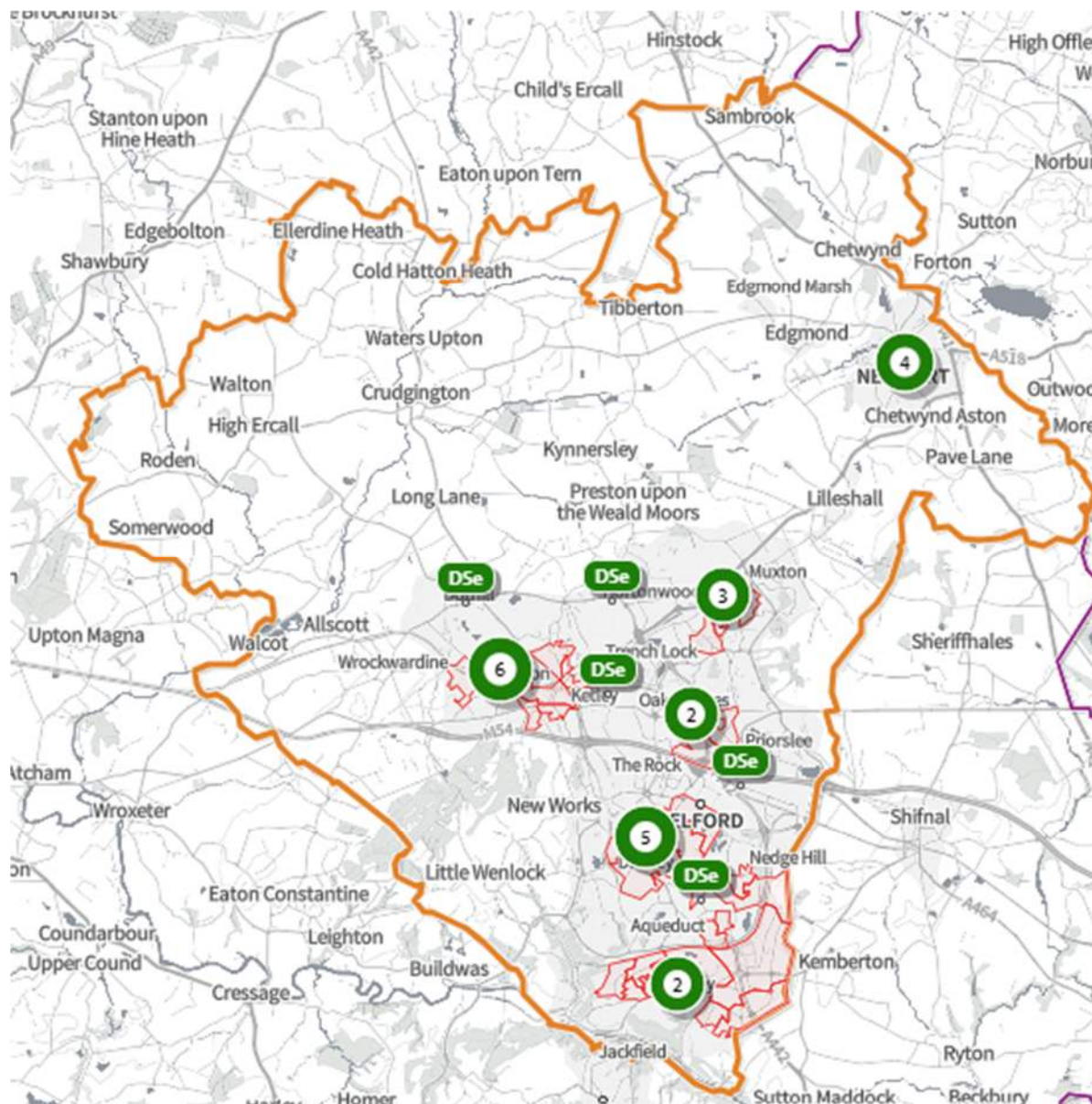

- Commission an additional 10,616 UDAs across Telford
 - Commission additional recurrent UDAs in local dental access hot spots where poor delivery by existing providers is impacting on local access - including Newport (2,000 UDAs)
 - Commission UDAs within existing Orthodontic dental contracts to ensure that patients undergoing orthodontic treatment have access the full range of dental services

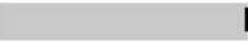

- Urgent Dental Care incentive Scheme

Location of dental practices in TW delivering NHS services

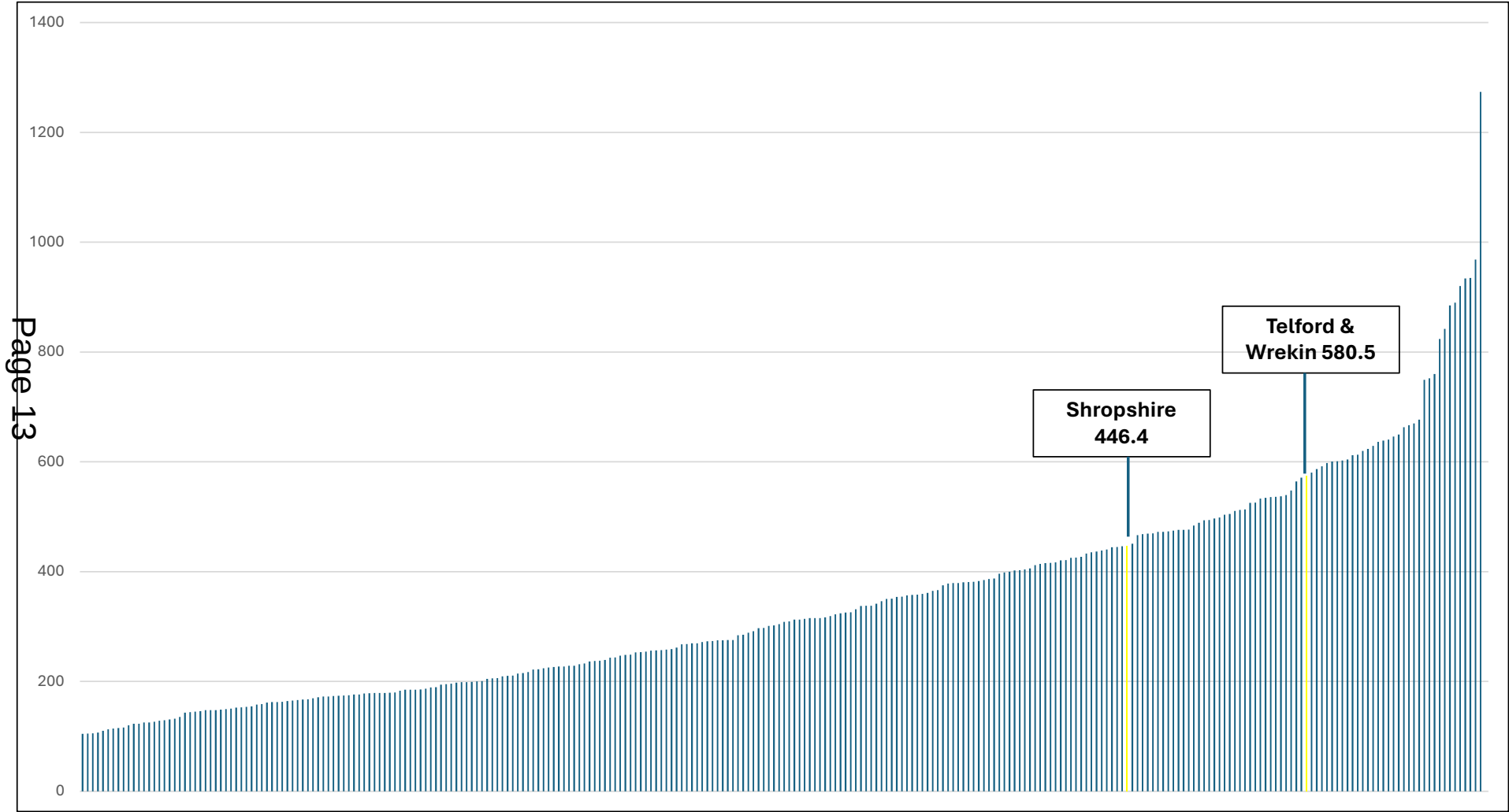


DSe means 'Dental service' and indicates a single service in that location. The numbers indicate multiple practices in the area

Percentage of 5-year-olds with experience of visually obvious dental decay 2023-24 – TW compared to England

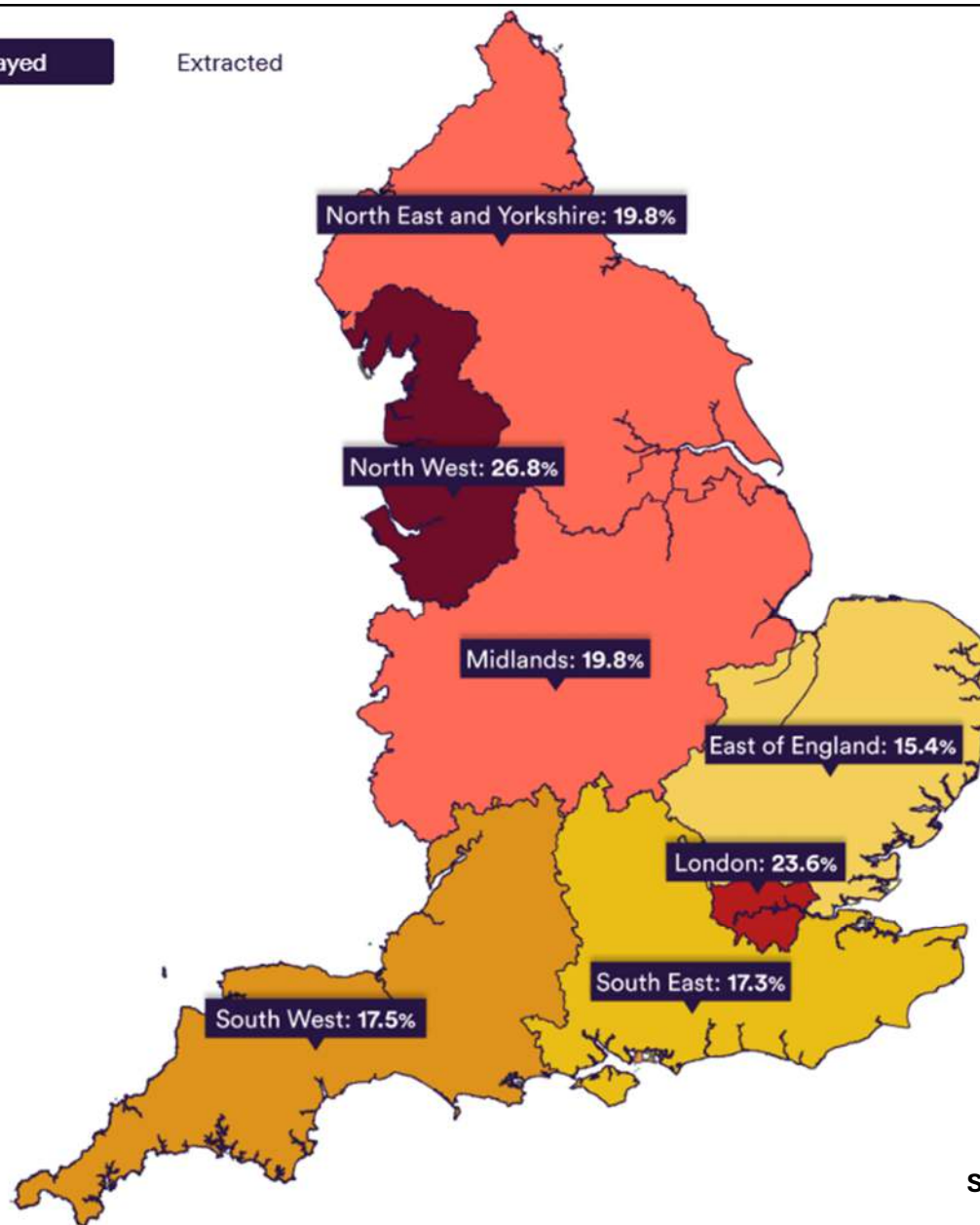
