182 <u>Leader's Report & Announcements</u>

The Leader, with agreement from all Group Leaders, had agreed not to give a Leader's speech but tabled an urgent motion.

a) Councillor S Davies moved, in accordance with Council Procedure Rule 7, the following Motion:

"This Council condemns the senseless, brutal, and disastrous invasion of Ukraine by Russia and denounces the actions of Vladimir Putin and the Russian Government

We stand in solidarity with the Ukrainian people including those in this Borough who may have family and friends living in Ukraine.

This Council resolves:

- 1. To condemn the illegal and immoral actions of the Putin Regime.
- 2. To do all it reasonably can to support the displaced Ukrainian people and those affected within the Borough to coordinate our community to support the ongoing relief effort as part of our nation's humanitarian response.
- 3. We ask that our Group Leaders write a joint letter on behalf our Council to our MPs calling on them to support all possible diplomatic and economic measures possible by the British Government to restrict Putin's regime military operations and to maintain the independence and freedom of Ukraine.
- 4. To express our support to NATO, UN and world leaders in their efforts to bring the matter to a safe and successful conclusion."

Councillors N Dugmore and B Tomlinson seconded the Motion.

Following debate, it was unanimously:-

RESOLVED - that the motion be approved.

183 Mayor's Announcements

The Mayor asked Members to note the report on Mayoral Engagements since the last meeting of full Council. Although it had been a quiet start to the year due to the ongoing pandemic, he had attended a number of engagements including the first anniversary celebration of Inflata Nation and the official opening of the new Randle House at Dawley Town Hall. His Mayoral Masquerade Ball would take place in March and he was looking forward to continuing the remainder of his term in office and attending future engagements.

No questions were received.

185 Councillor Questions On Notice

The following questions were asked under Council Procedure Rule 6.2.2:-

(a) Councillor N Dugmore asked the following question of Councillor S Davies, Leader.

"When will the remaining Afghan refugees that after several months are still in temporary accommodation be moved to permanent accommodation?"

Councillor S Davies responded that those who had been evacuated from Afghanistan were currently in temporary hotel accommodation, placed by the Home Office. Consequently, the Council had no involvement or control over this as the Home Office decides on location of final and permanent accommodation. The Council had permanently placed some families and had written to the Home Office and Secretary of State to ask that urgent steps are taken in order to allocate permanent housing to those who have been placed in hotels for several months.

Councillor N Dugmore asked a supplementary question:

"With the potential arrival of Ukrainian refugees, do you agree the current situation needs to come to a conclusion quickly and the Council should act quickly for houses to be decorated which is something that could easily be resolved by the Council."

Councillor S Davies responded that the Council were looking after the Afghan refugees whilst they were in the Borough but onward settlement was not in the remit, or control, of the Council as those allocations and decisions were undertaken by the Home Office.

186 <u>Cabinet Decisions Made Since the Last Meeting of the Council</u>

Members received the report on the Cabinet decisions made since the last meeting of the Council.

187 <u>Council Plan 2022/23 to 2025/26</u>

Councillor S Davies, Leader, presented the report of the Chief Executive in relation to the 2022/23 to 2024/25 Council Plan. The Plan had been refreshed in order to drive the delivery of the Council's vision to protect, care and invest to create a better Borough and set out the focus during the next three years.

During the debate, the focus was on equal homes for all, enforcement action to be taken against landlords who failed to meet good standards of rented accommodation, education attainment in both primary and secondary education, trees and the green agenda.

Upon being put to the vote it was:

RESOLVED – that the Council Plan 2022/23 to 2025/26 be approved.

188 <u>Medium Term Financial Strategy 2022/23 to 2025/26</u>

Councillor R C Evans, Cabinet Member for Finance, Governance and Customer Services, presented the report of the Director: Finance & Human Resources (Chief Financial Officer) which set out how the Council would deliver the Strategy and its five key priorities. It sought approval of the Council's Medium Term Financial Strategy for the next four years together with the budget framework for 2022/23. A one year funding settlement had been received and there was increased demand for key services. There was a freeze on council tax for the next two years and the Council continued to invest in the Borough to make it an attractive place to live, work, learn and visit.

A debate followed which focussed on investment in key services, affordable homes, borrowing, improving the highways, footpaths, cycleways, green spaces and the freezing of council tax.

"This Council is deeply concerned about the cost of living crisis, which is having a devastating impact on household budgets across Telford and Wrekin – with every sign that things will only get worse.

This Council condemns the Conservative government's lack of action to support families and households across our Borough, instead, being focused on defending the alleged law breaking in Downing Street.

This Council believes that this government have continued to fail our residents by:

- Scrapping the £20 uplift for those on universal credit
- Increasing National Insurance by 10%
- Freezing personal tax allowances which will see more people pay more income tax than ever before
- Introducing a forced loan to every household energy bill rather than provide real support via an energy windfall tax

Whilst energy and tax bills will increase for the typical family to over £1,000 per annum, a £150 'rebate' is simply just a 'drop in the ocean' whilst this government writes off £4bn of fraud.

We therefore call on the Government and our Telford and The Wrekin MPs to do more to help households rather than letting off fraudsters and defending rule breaking in Downing Street" The Motion will be seconded by Councillor G C W Reynolds"

On behalf of our residents we will not consent to such a move. A Telford and Wrekin Council, under a Labour administration, is on the side of our residents and there are no circumstances where such a merger or an elected Mayor of Shropshire is acceptable for our residents. Telford and Wrekin Council will continue to put Telford and Wrekin first."

1.0 Recommendations for decision/noting:

It is recommended that -

- (1) Council appoints the Committees and Boards, as shown at Appendix 1 of this report, for the 2022/2023 Municipal Year, and approves the appointment of the Chair and Vice-Chair for each body;
- (2) The Monitoring Officer be authorised to give effect to nominations to Committees and Boards notified to her in writing by Group Leaders;
- (3) Confirmation of the Terms of Reference for each Committee and Board be delegated to the relevant Committee or Board; and

2.0 Purpose of Report

2.1 This report sets out the Committees and Boards to be appointed for the 2022/2023 municipal year; the Members who will serve on these bodies; and the proposed nominees for Chair and Vice-Chair.

3.0 Background

3.1 In accordance with the Constitution, the Annual Meeting of the Council will appoint such committees and boards as the Council considers appropriate to deal with matters which are neither reserved to the Council nor are Cabinet functions; will agree the size of each Committee; and will appoint a Chair, Vice-Chair, Members and substitute Members (where appropriate) for each committee and board in accordance with political balance rules.

4.0 Summary of main proposals

- 4.1 The various Committees and Boards to be appointed for 2022/2023 are shown at Appendix 1.
- 4.2 Political balance rules have been applied where appropriate in terms of:
- (a) the allocation of seats to political groups on each individual Committee/Board; and
- (b) the overall number of seats allocated to each political group reflecting the relative size of each group as a percentage of the total number of Council members.
- 4.3 Group Leaders have endorsed the allocation of seats to the Committees/Boards, based on the principles set out at paragraph 4.2. Each political group has submitted nominations to its allotted seats, and the proposed membership for each Committee/Board (including substitutes where appropriate) is shown at Appendix 1.
- 4.4 Appendix 1 also shows the nominees for Chair of each body and for Vice-Chair of each body (except for Scrutiny Board/Committees), for approval.
- 4.5 Council is also asked to re-assert delegated authority to the Monitoring Officer to appoint Members to Committees and Boards in accordance with the wishes of the Group Leaders as notified in writing. This delegation avoids the necessity to refer each nomination to Council and it is effectively an administrative task. If the delegation is approved, the Monitoring Officer must give effect to the nomination, provided it is lawful and not contrary to the Council's own procedure rules or when the appointment is exercisable only by the Cabinet.
- 4.6 It is requested that authority is delegated to the Monitoring Officer, in consultation with Group Leaders, to agree the political balance and committee seat allocations following any changes to the Council's makeup within the municipal year.
- 4.7 The Constitution requires Council to agree the Terms of Reference of all Committees and Boards. It is recommended that each Committee be authorised to review its own Terms of Reference.
