This council calls on NHS leaders locally and nationally together with the government to depart from the use of 'A&E' Local and calls on those Members of Parliament who have used it to apologise for adopting the term when it could undermine the safety of patients in the Borough."

<u>RESOLVED</u> – that the minutes of the meeting held on 13 July 2023 be confirmed and signed by the Mayor.

34 <u>Leader's Report & Announcements</u>

The Leader highlighted the significance of both local and national events that had occurred in recent months and the impact these events have had on local residents and communities.

Following the Government's Autumn Statement, the Leader stated that recent headlines had seen reductions in national insurance, however independent organisations would continue to be affected by the burden created from local



taxation and local authorities would receive little investment for services that matter the most in their communities.

The Council had seen budgetary challenges throughout the year as a result of the impact of inflation, however had continued to invest funding into vital services.

The Leader provided an update that following a 6 month wait for a response from the Department of Health, it had been confirmed that the plans to downgrade the A&E and move the consultant-led women and children's centre from the Princess Royal Hospital to Shrewbury were being reconsidered by the Independent Reconfiguration Panel.

35 <u>Mayor's Announcements</u>

The Deputy Mayor noted the engagements that the Mayor had undertaken since the last meeting of Council. In particular, he highlighted a recent visit to Crucial Crew at Telford College and the Mayor's forthcoming Christmas Carol Service which would commence the start of the festive season.

36 <u>Public Questions</u>

No questions were received.

37 <u>Councillor Questions On Notice</u>

The following questions were asked under Council Procedure Rule 6.2.2:-

 (a) Councillor S Handley asked the following question of Councillor L D Carter, Cabinet Member: Place (The Economy & Neighbourhood Services):

"As you are aware there has been increasing concern over the Holyhead Road by Central Park in St Georges, I know the current and previous Labour councillors for St Georges have been advocating for the road to be improved and have also wanted signals added to the junction of Furnace Road. This is a major scheme, and I would be delighted if the Cabinet Member for Place could inform me if there is a date now agreed for this project to commence and if the junction will be signalled to help improve road safety and ease congestion?"

Councillor Carter responded that the Council had recently undertaken a number of major improvement schemes across the Borough and in particular a number of challenging repairs to structures and retaining walls in the Ironbridge Gorge World Heritage Site. The Council would be investing a further £24m into transport and highways schemes and improvements to

Holyhead Road in St Georges will take place in the New Year with works set to commence in late January. The project would see improvements to the retaining wall, resurfacing of the roads and footpaths as well as the introduction of a signalised junction to include pedestrian crossing facilities.

(b) Councillor H Morgan asked the following question of Councillor K Middleton, Cabinet Member: Health, Safer & Stronger Communities and Partnerships:

"I'm really pleased to see that Telford and Wrekin are spreading the message of zero tolerance on violence to both men and women. There is a funding gap for community services for domestic abuse and since the pandemic there has been an increase of 20% in reported domestic violence so to see our local authority prioritise this is brilliant to see. Can you tell me a little more about any planned work in the area that will help continue the White Ribbon message in the long term?"

Councillor Middleton responded that the Council would be investing £1.5m over the next three years to provide a new domestic abuse support service which would be delivered by not-for-profit organisations Cranstoun and West Mercia Women's Aid. The Council's Building Safer & Stronger Communities programme had supported more than 200 women to complete free self-defence classes with further sessions planned for the New Year. The annual Telford 5K Park Run continues to raise awareness of domestic abuse and those who attend the park run are encouraged to sign the pledge.

(c) Councillor A D McClements asked the following question of Councillor R Mehta, Cabinet Member: Inclusion, Engagement, Equalities & Civic Pride:

"Since 2011, under this administration, the Councillors Pride Fund has given ward members the opportunity to allocate funding towards improvements or projects within their ward. This funding has given all 54 councillors the opportunity to make a big difference with a small amount of money, supporting many hundreds of projects that benefit local communities, improving the lives of their community during these difficult times. Could the Cabinet Member for Inclusion, Engagement, Equalities & Civic Pride confirm whether this much needed funding will continue to delivered 2024/25?" be in

Councillor Mehta responded that the Council have delivered a huge amount of projects for more than a decade, making a difference to communities. More than £1.5m has been invested into the Councillors Pride Fund scheme with further investment planned for 2024/25.

(d) Councillor E Davies asked the following question of Councillor C Healy, Cabinet Member: Climate Action, Green Spaces, Heritage & Leisure:

"I was pleased to be able to open the newly refurbished Princes End play area and it has been wonderful to see the difference this has made for the children in my ward. What else is the council doing to improve children's play opportunities across the borough?"

Councillor Healy responded that the Council had recently investment £750k into play areas around the Borough with 38 play areas upgraded and a further 7 still planned for redevelopment. Investment had included more accessible play facilities for children with disabilities as well as the introduction of facilities which cater for the needs of teenagers.

Councillor E Davies asked the following supplementary question:-

"All of our play parks within the ward are located within valuable green spaces, many of which are green guarantee sites. Can the Cabinet Member work with me and my fellow ward member to designate all of them into green guarantee sites and ensure that this is communicated effectively to residents?"

Councillor Healy responded over the last year the Council have increased the number of Green Guarantee sites from 200 to over 300, designating a vast majority of the Borough's open space including play areas. The Council were currently in the process of rolling out a programme of signage installation to make residents aware that these spaces are protected sites and are available to enjoy.

- C) To praise our NHS staff who continue to work to offer the best possible service whilst dealing with the continued underfunding.

1.0 Recommendations for decision/noting:

Full Council is asked to approve:

- 1.1 The calculation of the tax base for 2024/25 as at paragraph 4.4 and Appendix A; and
- 1.2 In Accordance with the Local Authorities (Calculation of Council Tax Base) Regulations 2012 (SI 2012:2914), the amount calculated for Telford and Wrekin Council Tax base for 2024/25 for its Special Fund Area shall be as per the appropriate parish amounts detailed in Appendix A for the parishes listed in paragraph 4.5.

2.0 Purpose of Report

2.1 To determine the Council Tax Base for General and Special Fund purposes for the financial year 2024/25. The setting of the Council Tax Base is the first stage in the process of setting the Council Tax for 2024/25. Final recommendations on council tax levels will be presented to Full Council on 29 February 2024.

3.0 Background

- 3.1 In order to determine the appropriate Council Tax levels for the area, it is necessary for the Council to determine the tax base for its area or part of its area. The budget requirements of the various precepting authorities are divided by this figure to arrive at the Band D equivalent level of Council Tax.
- 3.2 The tax base for 2024/25 must be set by Full Council between 1st December 2023 and 31st January 2024 as prescribed by section 8 of the Local Authorities (Calculation of Council Tax Base) Regulations 2012 (SI 2012:2914).

4.0 Summary of main proposals

4.1 **Council Tax Base Information**

As members will be aware, the Council Tax is a banded capital value based property tax.

The main features of the tax are:-

- Each domestic property is allocated to one of 8 bands depending on its capital value which has been set by the Valuation Office Agency.
- Section 5 of the Local Government Finance Act 1992 sets out the range of property values within each band. Associated Regulations determine the relationship between the tax rates for each band.
- A 25% discount from the full charge is available for single adult households. Certain categories of resident are disregarded in deciding the number of adult residents. These include students, student nurses, youth training trainees, the severely mentally impaired etc. Qualifying criteria must be met before discounts or disregards are allowed.
- A reduction equivalent to one council tax band is available where a resident of a dwelling is disabled and certain facilities are required for meeting the needs of that disabled person. For Band A properties the reduction is equivalent to 1/9th of the Band D Charge so the charge for such a Band A dwelling is 5/9ths rather than the usual 6/9ths for a Band A property.
- Council Tax Reduction is applied to the council tax base as a discount that varies depending on personal circumstances and this reduces the Council Tax Base.

The Council Tax Bands range from A to H and the details are as follows:-

4.2 **Property Base**

There are 82,624 properties in the valuation list for the Telford & Wrekin area. This compares with a figure of 81,225 in the list at the same time last year. This is an increase of 1,399 properties (which equates to an increase of 1,257.9 "Band D equivalent properties" to the Council Tax Base), an increase of 1.72%. The assumed rate of collection will remain at 99.25%. Total council tax receipts (including for the fire and police authorities) will be approximately £2.435m greater as a result of growth in the tax base. Telford & Wrekin Council's share of this is £1.841m. The growth is equivalent to a council tax increase of 2.27% and will help support services provided by the council, fire service and police service. Overall there has been a decrease in the proportion of Band A and Band B properties and increases in the proportions of Bands C to F, particularly in Band C.

4.3 Council Tax Base

To arrive at the Council Tax Base, it is necessary to undertake the following calculation in respect of each tax band:

Total number of chargeable dwellings (Less) Dwellings subject to discounts = Total equivalent number of properties x Ratio to Band D = Relevant Amount (Band D Equivalent)

The relevant amounts for each tax band are then aggregated to arrive at the total for the area.

Finally, an estimated Collection Rate needs to be applied to the resultant figure. This has to be common to the whole area and has to provide for amendments to the Council Tax Banding List, appeals against banding, additional discounts and losses on collection. Clearly every effort is taken to vigorously pursue all council tax due to the authority. As mentioned above we will use a figure of 99.25% for 2024/25.

4.4 General Fund Tax Base

This is the estimated council tax base for the whole of the area and will be used by Telford & Wrekin to calculate its General Fund Council Tax levy and also by The Office of the Police and Crime Commissioner for West Mercia and the Shropshire and Wrekin Fire & Rescue Authority to calculate the levy in respect of their precepts.

The tax base for this purpose for 2024/25 is 57,000.1 (including 154.9 for contributions in lieu in respect of MOD properties). Using an estimated collection rate of 99.25% (adjusted for 100% collection of contributions in lieu), **the tax base is calculated as 56.573.8**.

4.5 **Special Fund Tax Base**

This is the estimated council tax base for the Special Fund area, i.e. those areas where Telford & Wrekin Council provides services which, in other areas, are provided by Town & Parish Councils. These areas are;

- Dawley Hamlets,
- Great Dawley,
- Hollinswood & Randlay,
- Lawley & Overdale,
- Madeley,
- Oakengates,
- St Georges & Priorslee,
- Stirchley & Brookside,
- The Gorge,
- Wellington, and
- Wrockwardine & Trench.

The Council Tax Base for each can be found in Appendix A.

A Special Fund tax will be levied on those parishes that have opted not to take over the responsibility for footway lighting in their area. These are:-

- Dawley Hamlets,
- Great Dawley,
- Hollinswood & Randlay,
- Lawley and Overdale,
- Madeley,

- Oakengates,
- Stirchley & Brookside,
- The Gorge, and
- Wellington.

If any of the other parishes that currently have responsibility for footway lighting decide to return these to Telford & Wrekin Council's responsibility then they will also have the additional charge.

The Special Fund Council Tax will be set taking into account the special fund services provided in each individual parish area and taking account of the tax base for each parish.

5.0 Alternative Options

5.1 The tax base for each parish area is calculated in accordance with statutory regulations.

6.0 Key Risks

6.1 In setting the tax base an assumption is made for losses on collection, the Council takes all reasonable steps to collect income due but the final collection rate may be higher or lower than the 99.25% assumed.

7.0 Council Priorities

7.1 Setting the council tax base is a legal requirement and is needed to calculate council tax levels for 2024/25 and therefore directly supports the delivery of all Council priorities.

8.0 Financial Implications

8.1 The information contained within this report is used in determining the Council Tax to be charged in 2024/25.

9.0 Legal and HR Implications

9.1 The legal requirements relating to the setting of the Council tax base are set out in the main body of this report. The Council has a statutory obligation to set the Council Tax Base by 31 January 2024 to enable the level of Council Tax to be then set in accordance with the statutory deadline of 10 March 2024. In summary the Council has the power and the duty to set the Council Tax Base in the way described in this report.

10.0 Ward Implications

10.1 The tax base is set at parish level in order to reflect the council tax due in each Town or Parish Council area. There are no direct impacts on specific wards.

11.0 Health, Social and Economic Implications

11.1 The Council Tax base calculation includes discounts and reductuions which supports the Council priorities in respect of Health, Social and Economic factors.

12.0 Equality and Diversity Implications

12.1 The Council Tax base calculation includes discounts and reductions, including disabled person discounts and single person occupancy discounts, which support Equality and Diversity.
