1.0 CHANGE TO APPLICATION DESCRIPTION

- 1.1 As consideration of the application has progressed it has become clear that a total of 4no, conditions need to be varied. These relate to:
 - Condition 2 (variation of approved drawings)
 - Condition 3 (variation of HGV routing plan)
 - Condition 4 (variation of ecology report)
 - Condition 6 (variation of hours of operation, i.e. HGV movements)

Therefore the application description has been amended to reflect this.

2.0 CONSULTATION COMMENTS RECEIVED

- 2.1 TWC Ecology: Support Subject to Conditions and Informatives
 - Condition: Development to be carried out in accordance with submitted Ecological Reasonable Avoidance Measures Report
- 2.2 Coal Authority: No Objection
- 2.3 Lawley & Overdale Parish Council: Comment
 - Request wheel washing and road cleansing facilities.
 - Acknowledge changes to HGV movement accessing the application and that these are preferable to those previously approved.

3.0 AMENDMENTS TO HGV ROUTING PLAN

- 3.1 Following further discussion the applicant has submitted a new HGV routing plan which avoids using Grange Central and Malinsgate for HGVs travelling between the donor site and application site.
- 3.2 The new route would see HGVs leaving the donor site via Ironmasters Way, Lawn Central and Hollinshead, onto Rampart Way and Hall Park Way to pick up West Centre Way. This would avoid the town centre and areas most likely to be used by pedestrians.

4.0 OFFICERS COMMENTS

- 4.1 Officers support the amendments to the HGV routing plan and have added an appropriate ecology conditions to the recommendation.
- 4.2 The previous application, TWC/2016/1119, included a HGV routing plan that took the route now being proposed by the applicant and this is a fall-back position to be given significant weight in the material consideration of this application.
- 4.3 The previous recommendation contained a requirement for the applicant to submit information pertaining to the management of HGVs around site access on Old Park Way. In agreement with the Local Highways Authority this will now be dealt with by condition post-decision and has therefore been removed from the recommendation as a matter to be agreed prior to any permission being formally granted.
- 4.4 The comments raised by the Parish Council have been addressed by conditions proposed.

5.0 RECOMMENDATION

- 5.1 Based on the conclusions above, the recommendation to the Planning Committee on this application is to **GRANT PLANNING PERMISSION** to the Development Management Service Delivery Manager, subject to the following:
 - A) No further representations being received during what remains of the consultation period which raise material considerations which are, in the opinion of the Development Management Service Delivery Manager after consultation with the Chair of Planning Committee, of such significance that the application should be reported back to Planning Committee for re-consideration and determination.
 - B) The following Condition(s) and Informative(s) (with authority to finalise and impose additional Conditions to be delegated to the Development Management Service Delivery Manager):
