  - 1. A Licensing Committee dealing primarily with matters under the Licensing Act 2003 and the Gambling Act 2005
  - 2. A Regulatory Committee dealing with licensing under other legislation to include, but not limited to, that relating to taxis, street trading and animal boarding.
- 9.3 Telford and Wrekin will have two Committees for licensing moving forward, in line with accepted common practice.
- 9.4 This report relates to Terms of Reference for the Licensing Committee
- 9.4 The Constitution requires that Full Council should agree at its Annual Meeting the Terms of Reference for each of its Committees. At the Annual Meeting of the Council on 15 May 2025, Full Council delegated authority to each Committee to review its own Terms of Reference.

The Council's Constitution sets out that the Chair of Committees shall be decided at the Annual meeting of Full Council. Accordingly, the terms of reference for the Committee should mirror these provisions. It is also prescient for the terms of reference to provide clarity on the election of a Vice-Chair for the Committee.
