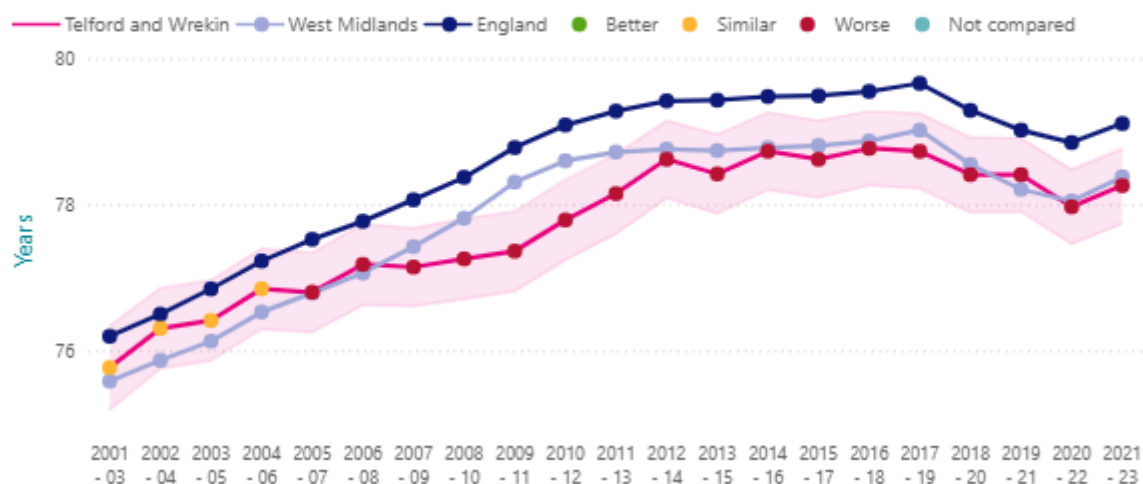

Life Expectancy at Birth

- Average life expectancy at birth for men in the borough was 78.3 years in 2021-23, compared to 79.1 years for England. Compared with women in the borough, men live 3.7 years fewer on average.
- The trend over time showed male life expectancy increasing between 2001-03 and 2012-14, however since that point the increase has stalled. Male life expectancy at birth has increased by 0.3 years from 2020-22 to 2021-23 after decreasing by 0.4 years from 2019-21 to 2020-22:

Life expectancy at birth - Male

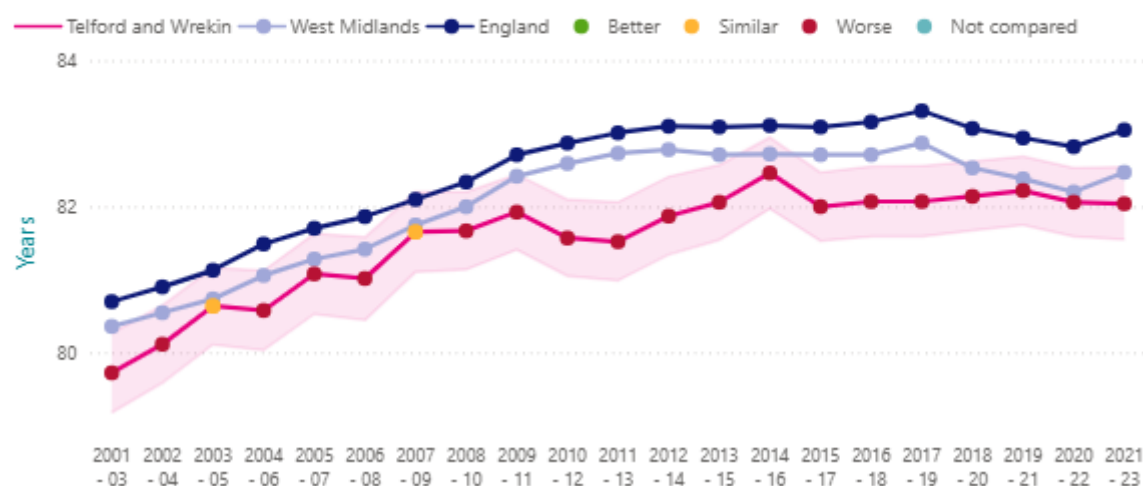

- Average life expectancy at birth for women in Telford and Wrekin was 82.0 years in 2021-23, compared to 83.1 years for England. Compared with men in the borough, women live 3.7 years longer on average. The trend over time showed life expectancy for women increasing between 2001-03 and 2014-16, however since that point the increase has stalled:

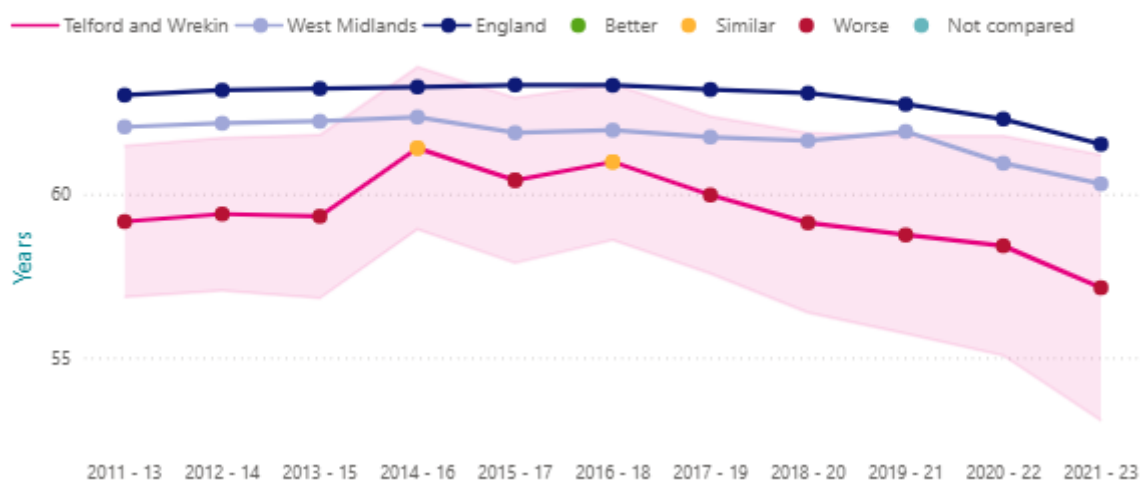

Healthy life expectancy at birth - Male

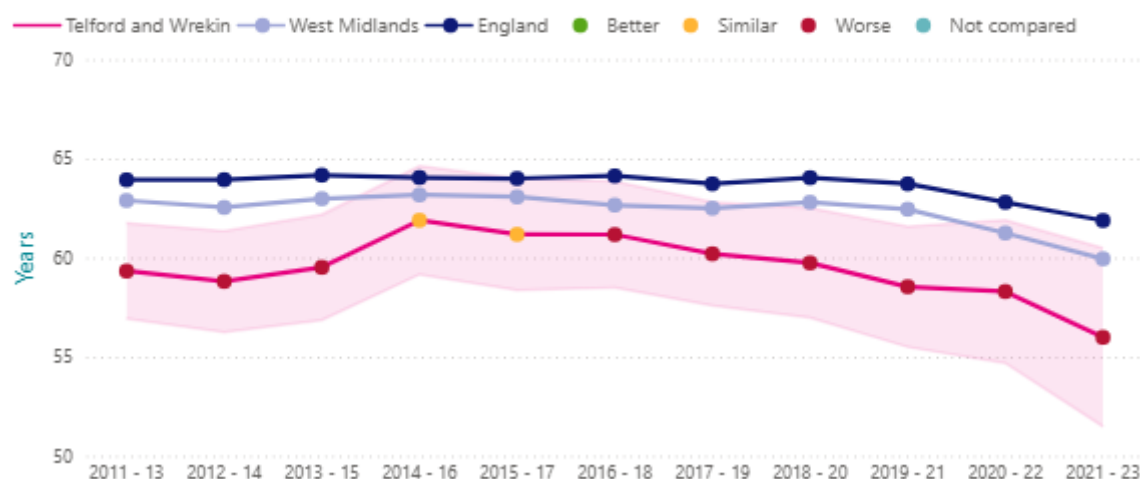

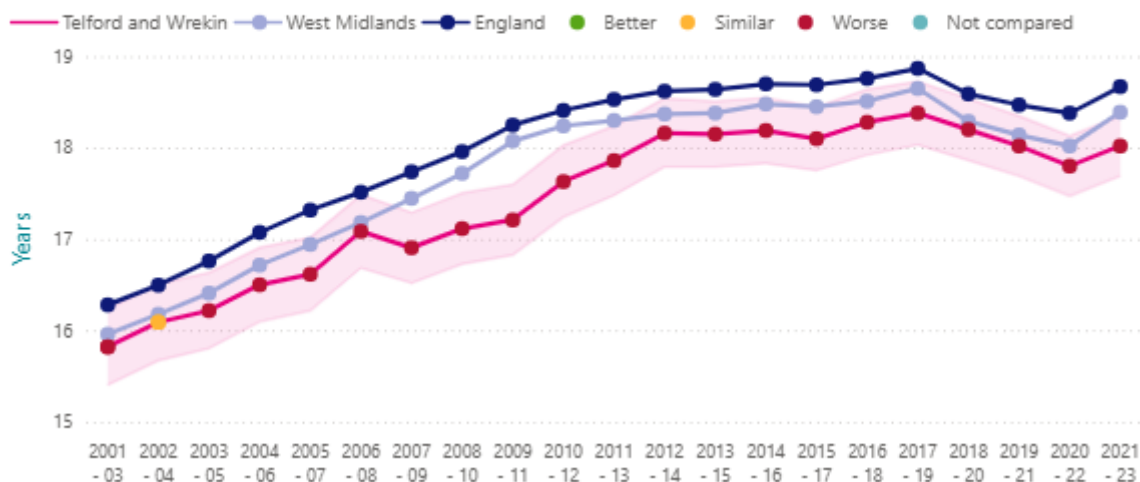


Life Expectancy at 65

- Average life expectancy at age 65 for men in the borough was 18.0 years in 2021-23, 0.7 years less than the England average (18.7). The trend over time showed male life expectancy at 65 increasing up to 2017-19, then decreasing up to 2020-22, where male life expectancy at 65 increases again by 0.2 years from 2020-22 to 2021-23:

Life expectancy at 65 - Male

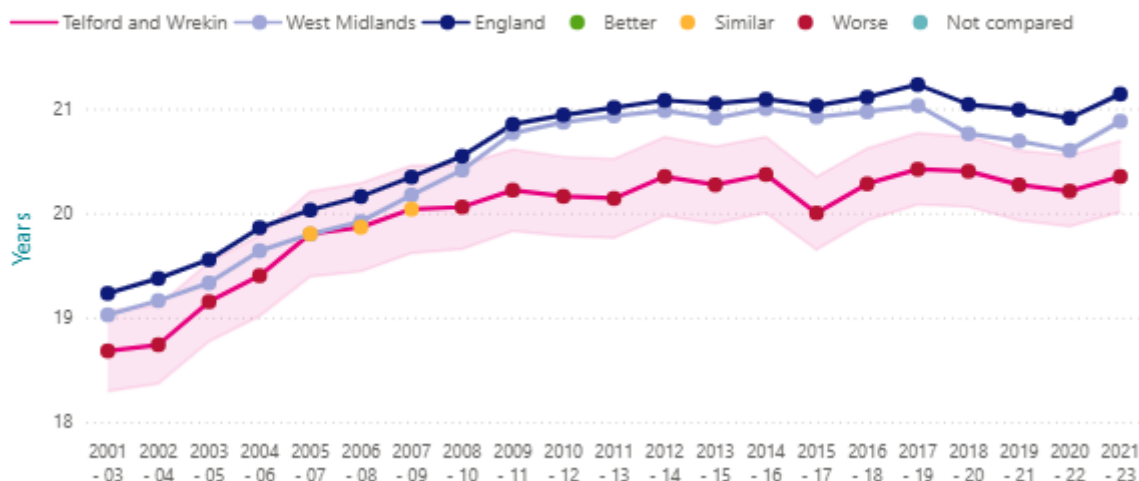

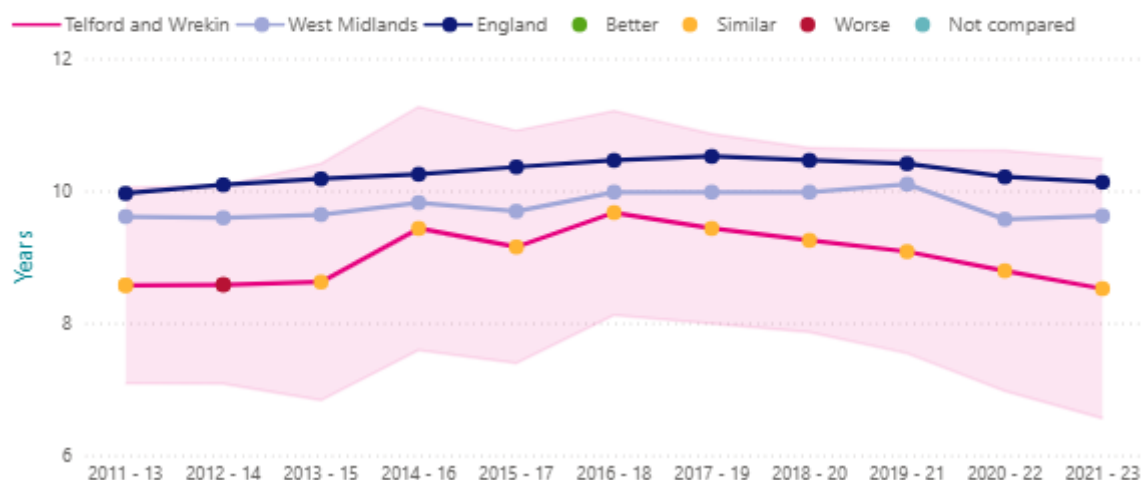


Healthy Life Expectancy at 65

Healthy life expectancy at 65 - Male

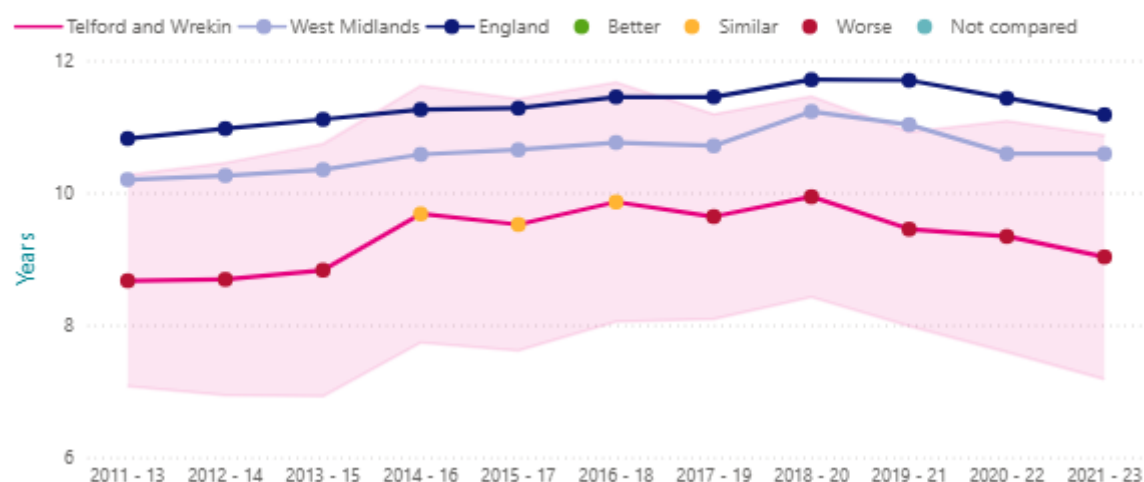

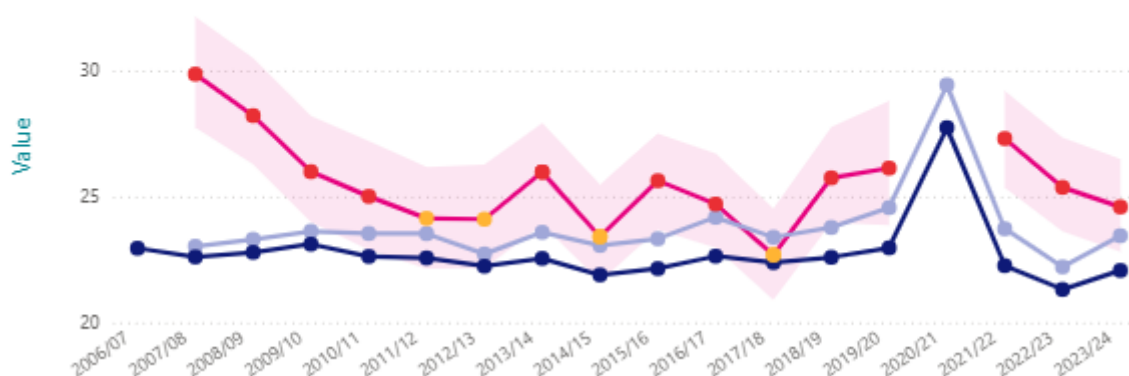

- The proportion of children classed as overweight in Telford and Wrekin in 2023-24 was worse than England for reception. In 2023/24, 1 in 4 children in reception were overweight or obese. At 24.6% this was a decrease of 2.7 percentage points from 2021-22:

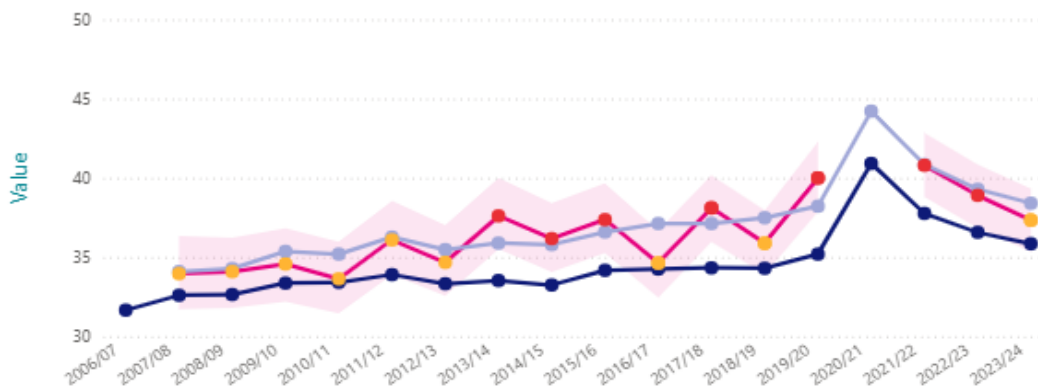

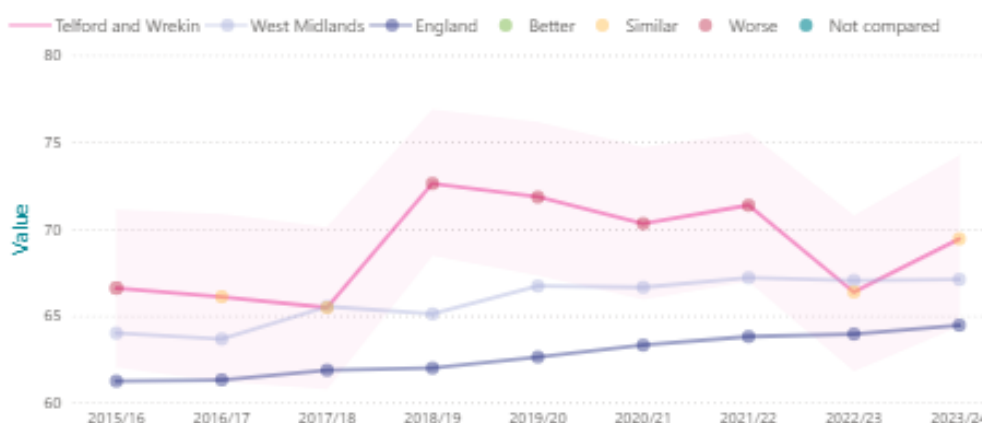

Overweight (including obesity) prevalence in adults, (using adjusted self-reported

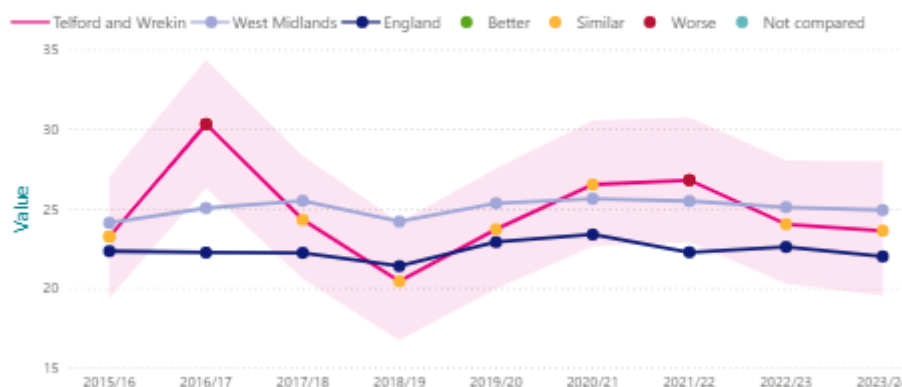

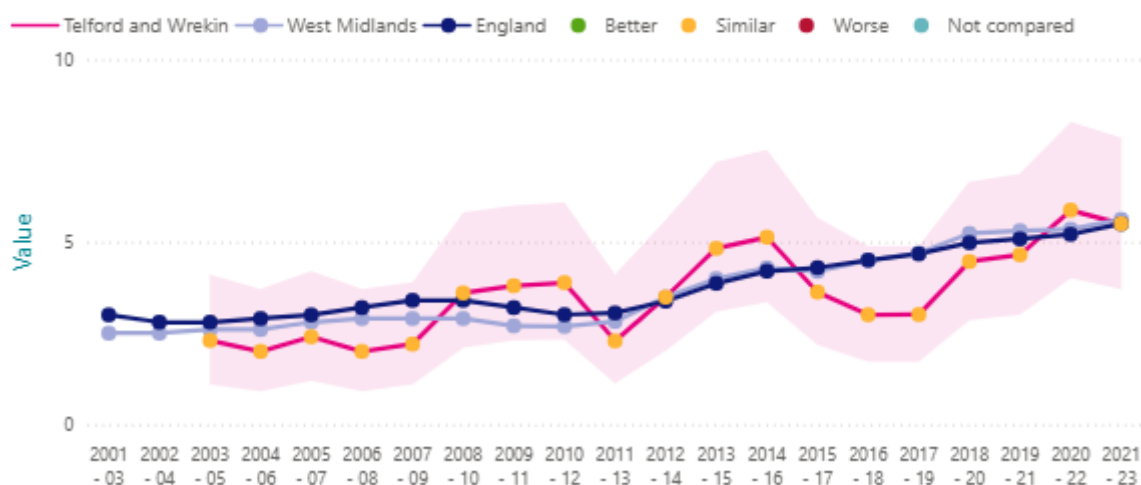

Deaths from drug misuse - Persons

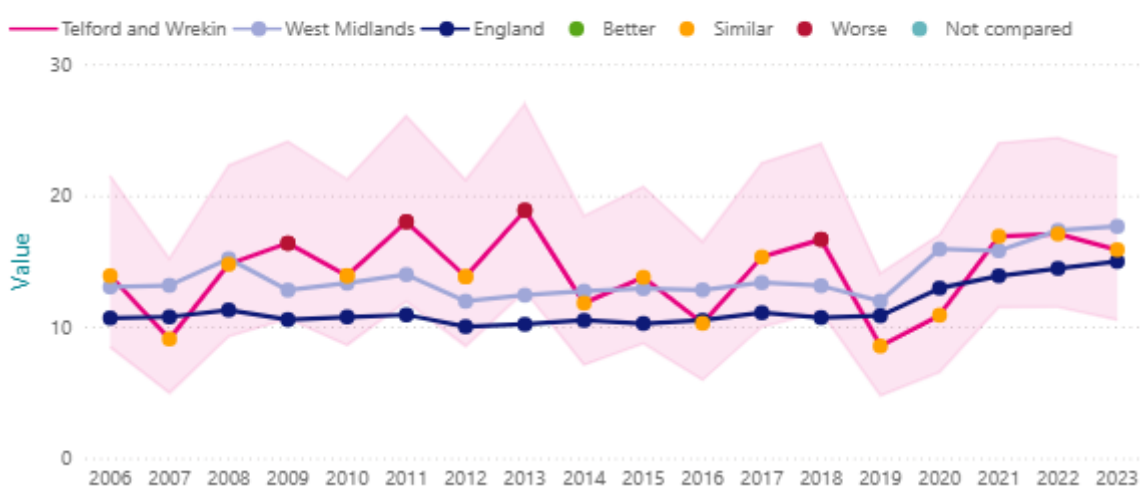

Alcohol-specific mortality - Persons - 1 year

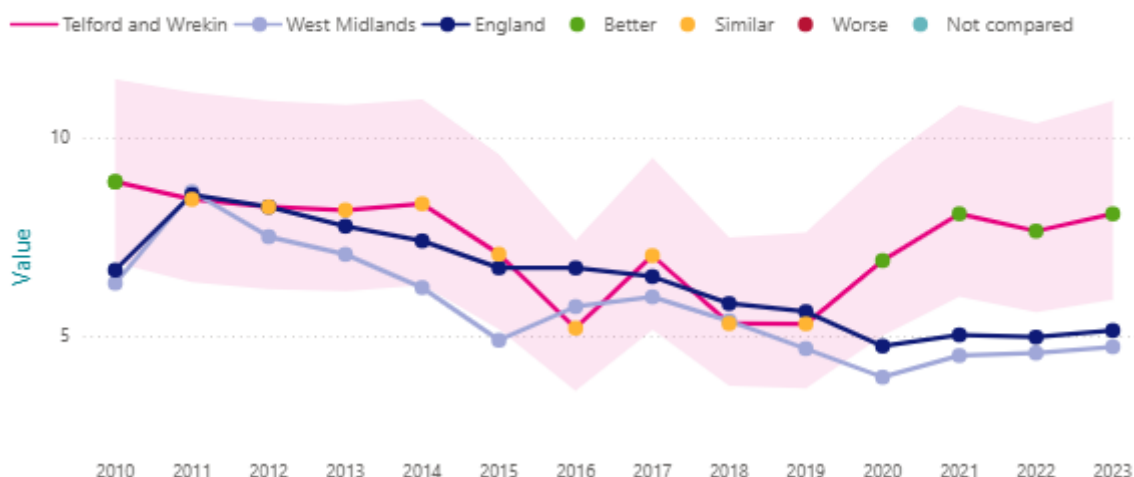

Successful completion of drug treatment: opiate users - Persons

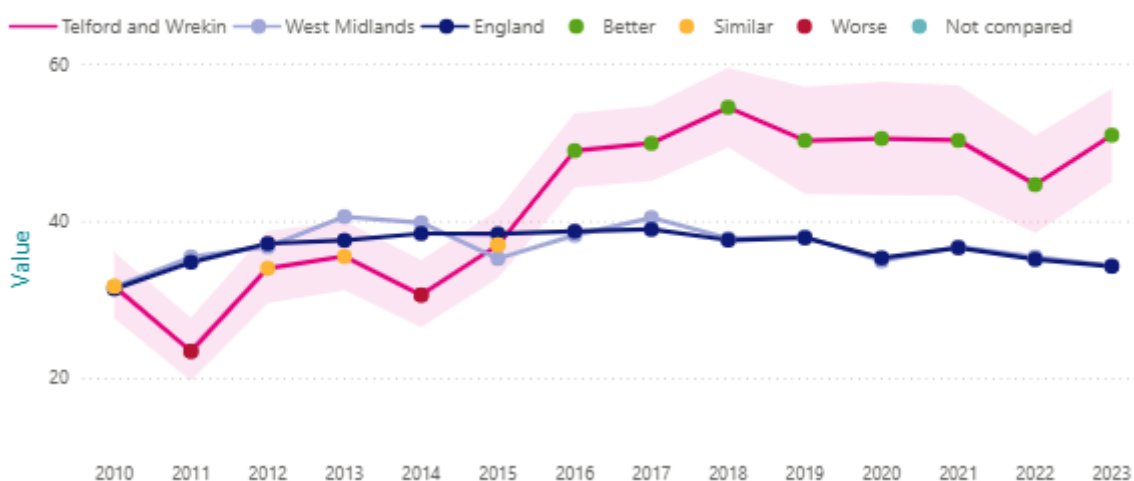

Successful completion of alcohol treatment - Persons

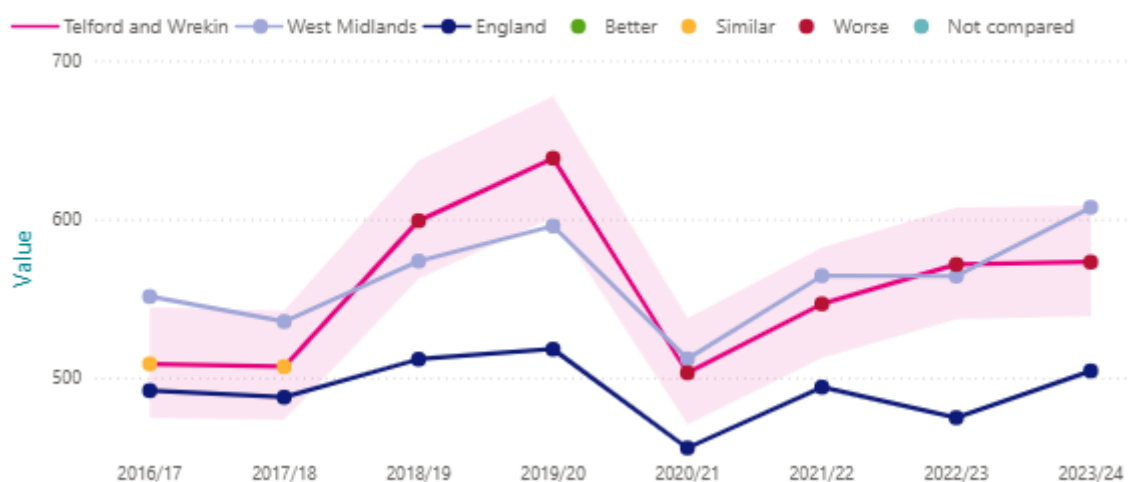

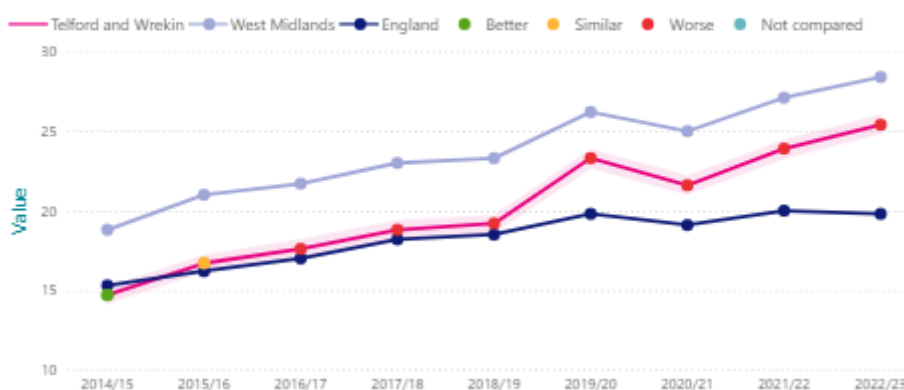

- There was a significantly higher proportion of children living in relative low income families in 2022/23, with a rate of 25.4% compared to 19.8% nationally. The rate has been worse than the England average since 2016/17. 1 in 4 under 16s were living in relative low income families compared to an England average of 1 in 5:

Children in relative low income families (under 16s) - Persons

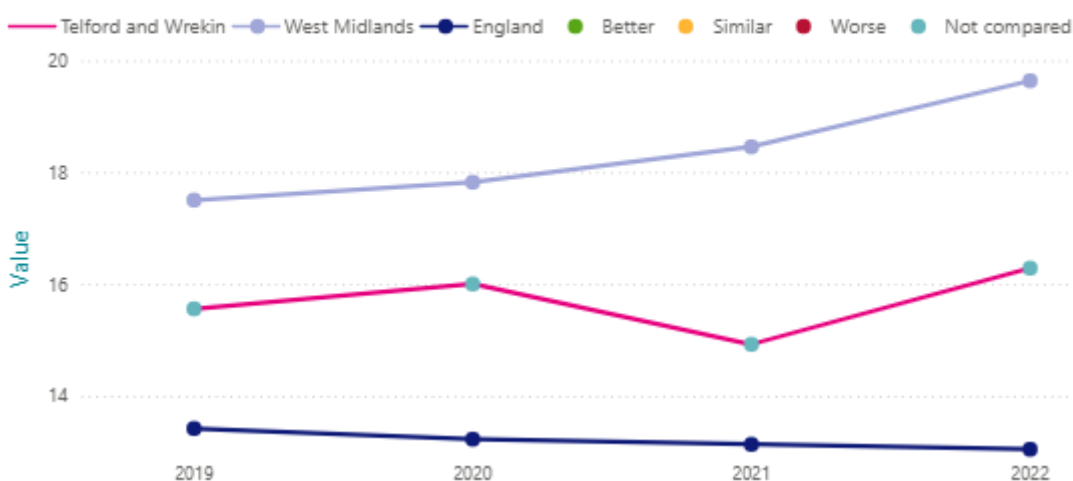

- In 2022 around 16.3% of households in the borough were in fuel poverty, higher than the England average of 13.1:

- In April 2025, 3.8% of people in the borough were claiming unemployment benefits, a lower (better) rate than England (4.2%)

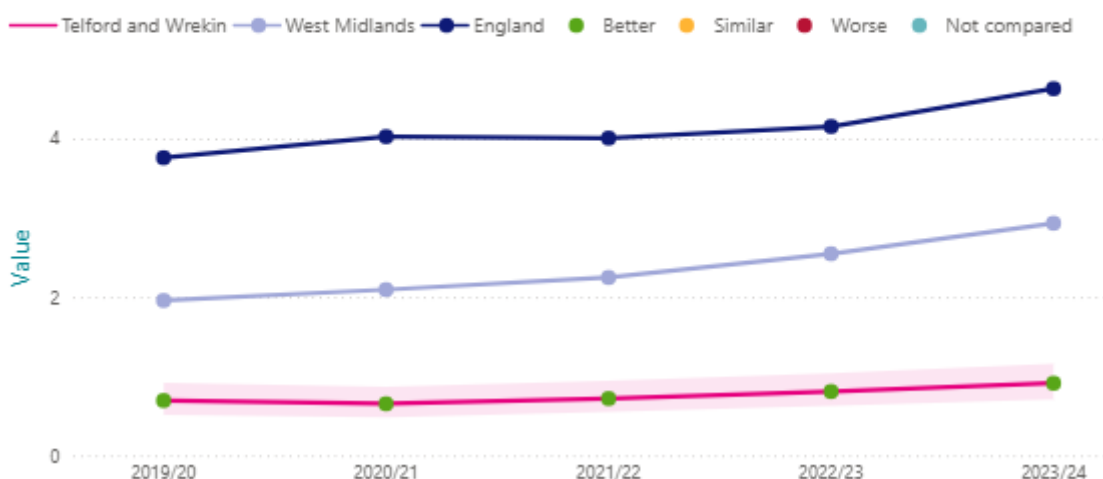

- The percentage of households in temporary accommodation, at 0.9%, is notably lower (better) than the national average of 4.6, and has remained low for a number of years:

- There is also notably better than national performance on the percentage of prevention and relief duties owed where accommodation was successfully secured, at 46.5% compared to the national average of 39.3%.
- It was estimated that the number of people sleeping rough on a single night in autumn 2024 in the borough was 7. This is a decrease from an estimated 20 in 2019.

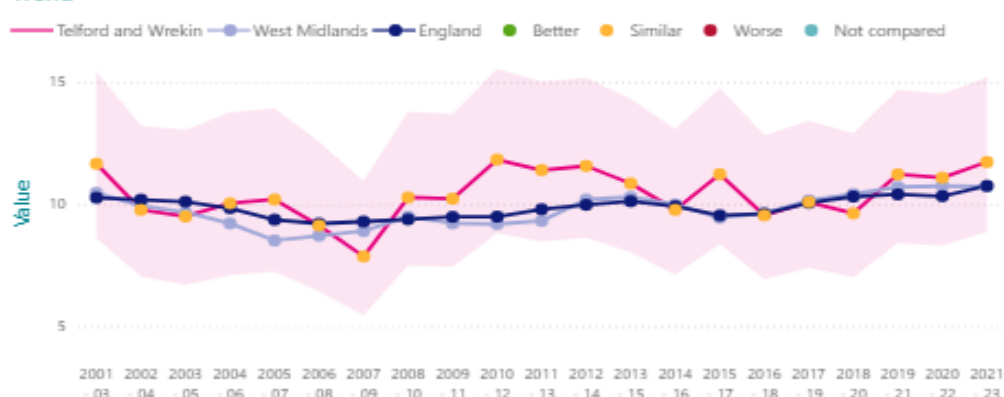

- The hospital admission rate for young people aged 10-24 as a result of self-harm, at 169.1 per 100,000, was better than the national rate (266.6). This equates to around 60 young people in 2023/24.
- The suicide rate in Telford and Wrekin has been similar to the England rate for a number of years:

Suicide rate - Persons

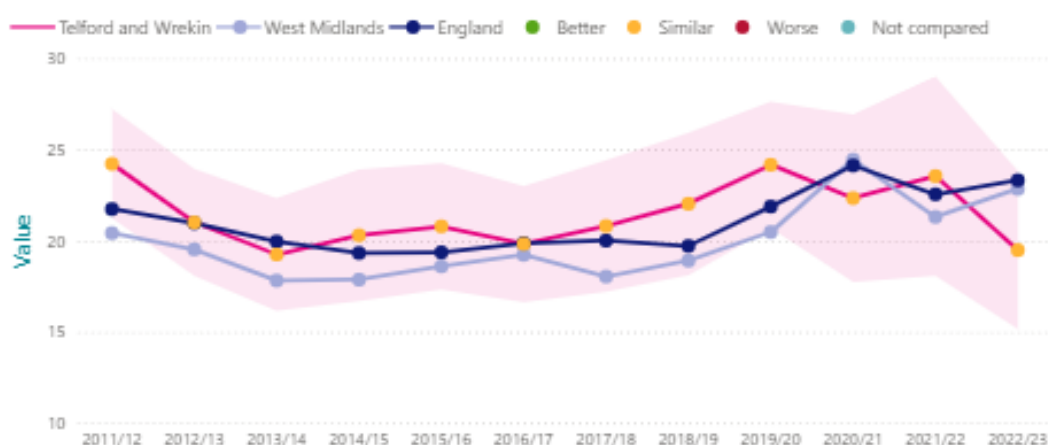

Self reported wellbeing: people with a high anxiety score - Persons

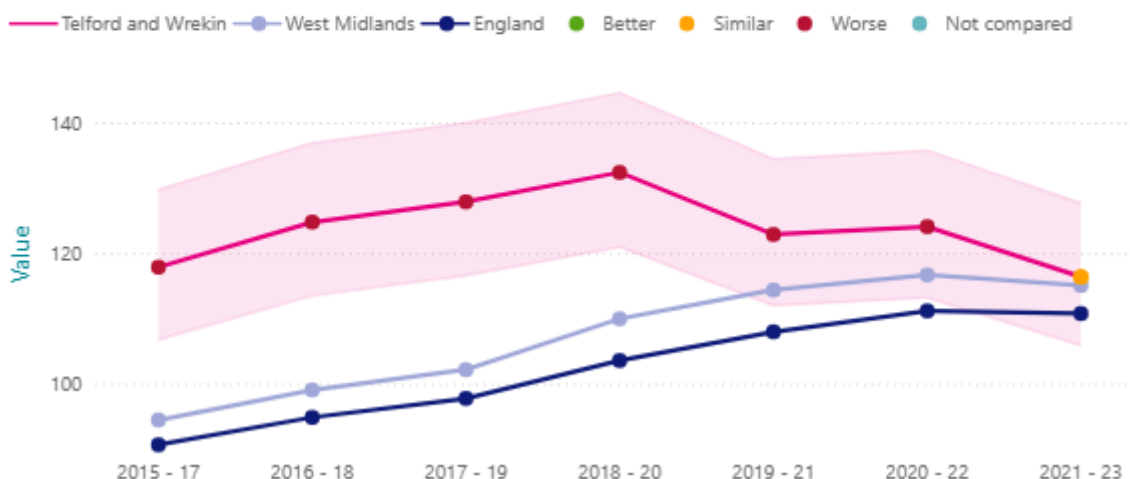

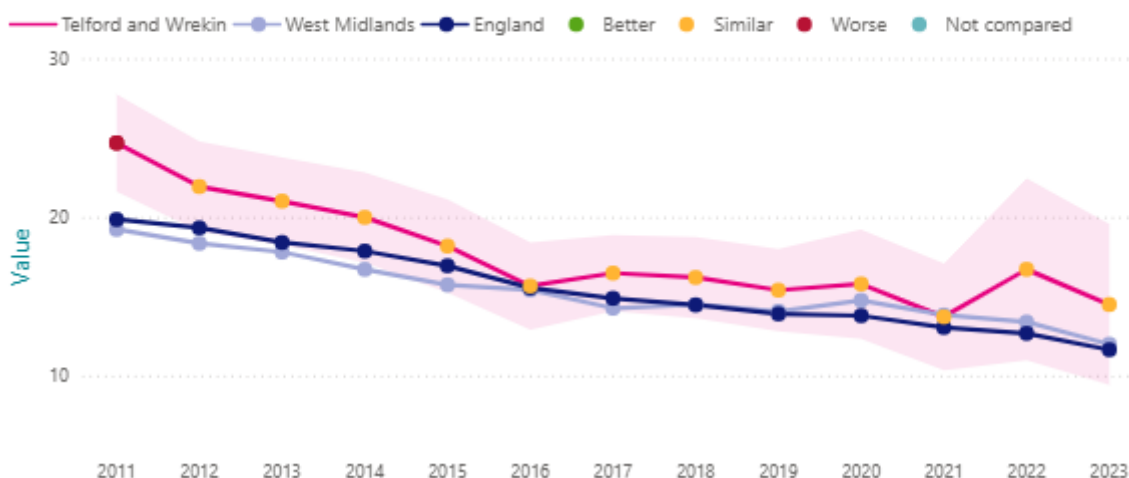

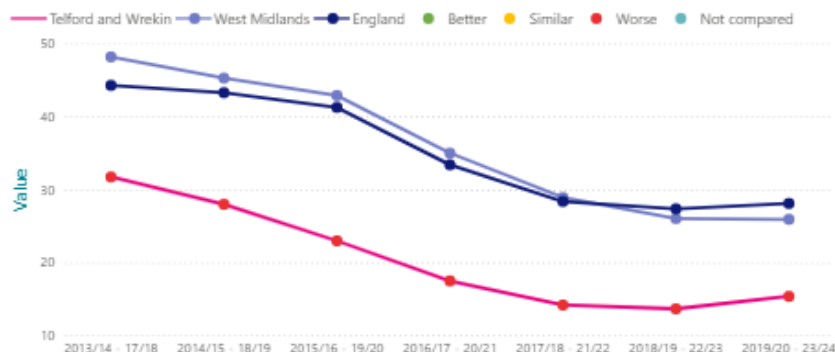

Cumulative percentage of the eligible population aged 40 to 74 who received an NHS Health check - Persons

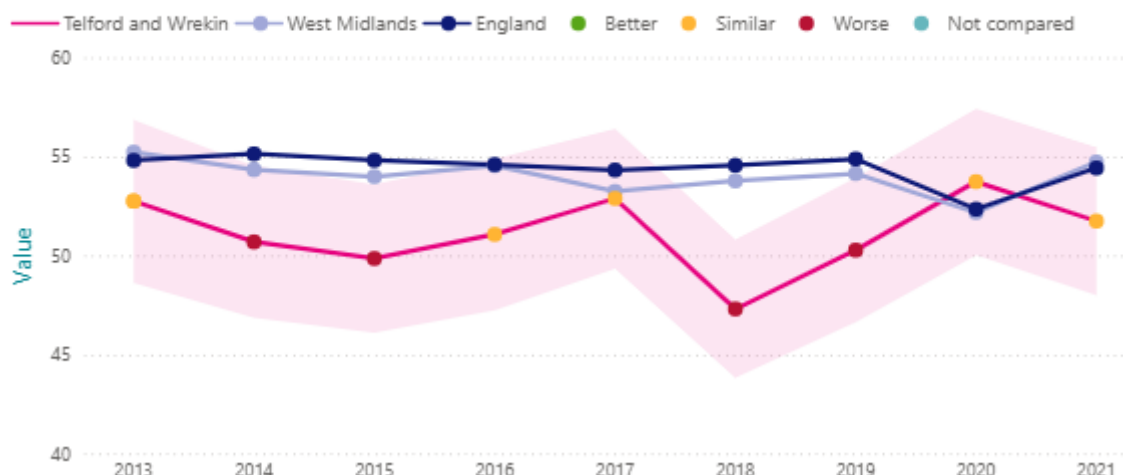

Percentage of cancers diagnosed at stages 1 and 2 - Persons

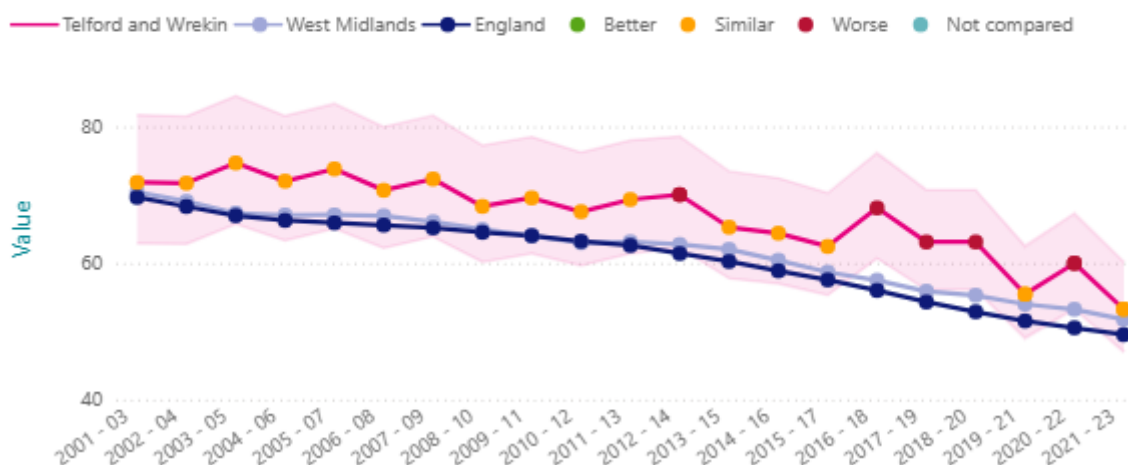

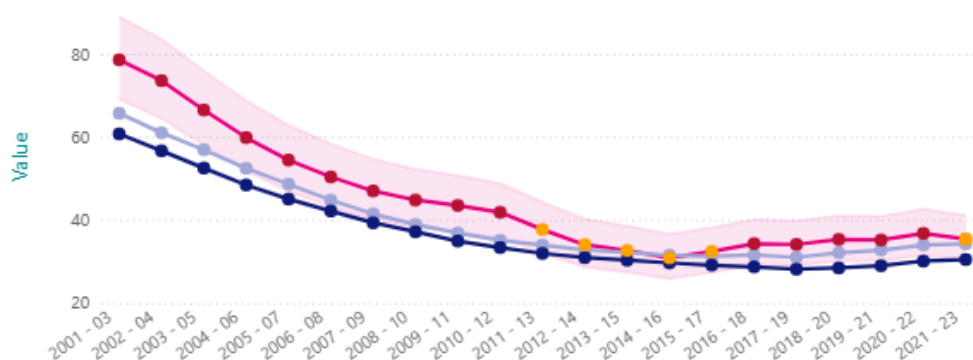

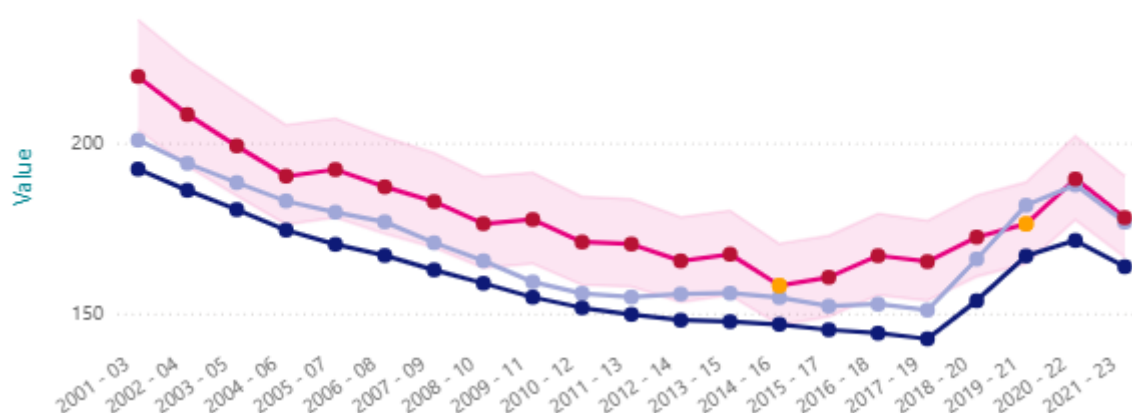

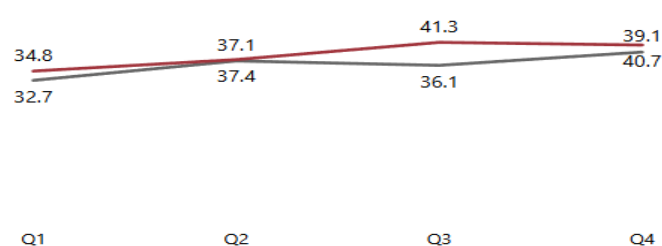

Breastfeeding Prevalence at 6-8 Weeks

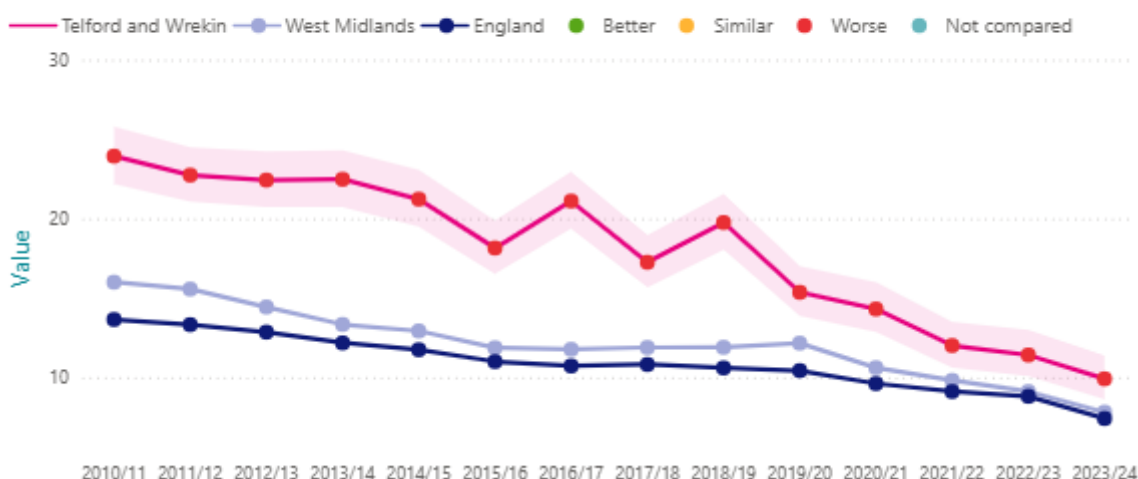

Smoking status at time of delivery - Female

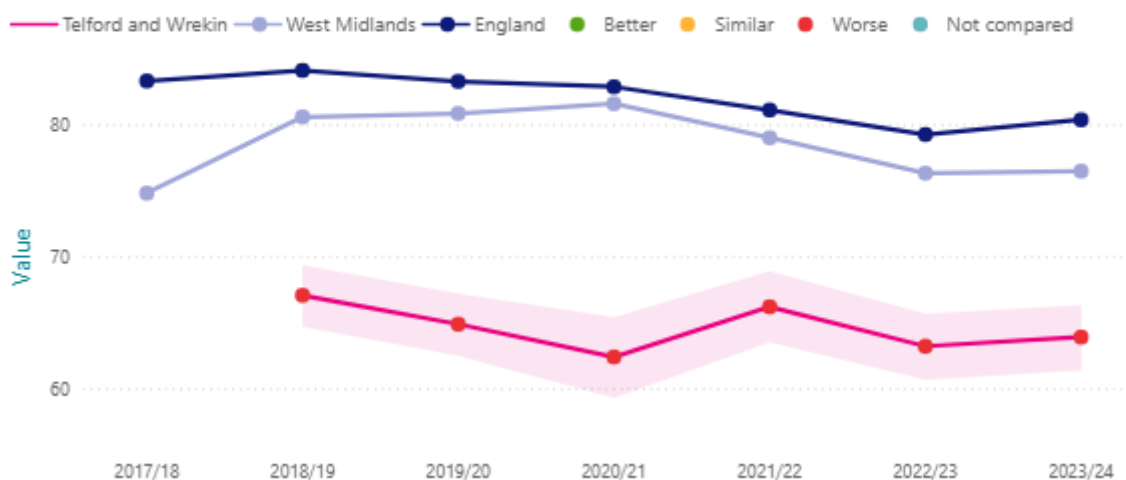

Child development: percentage of children achieving a good level of development

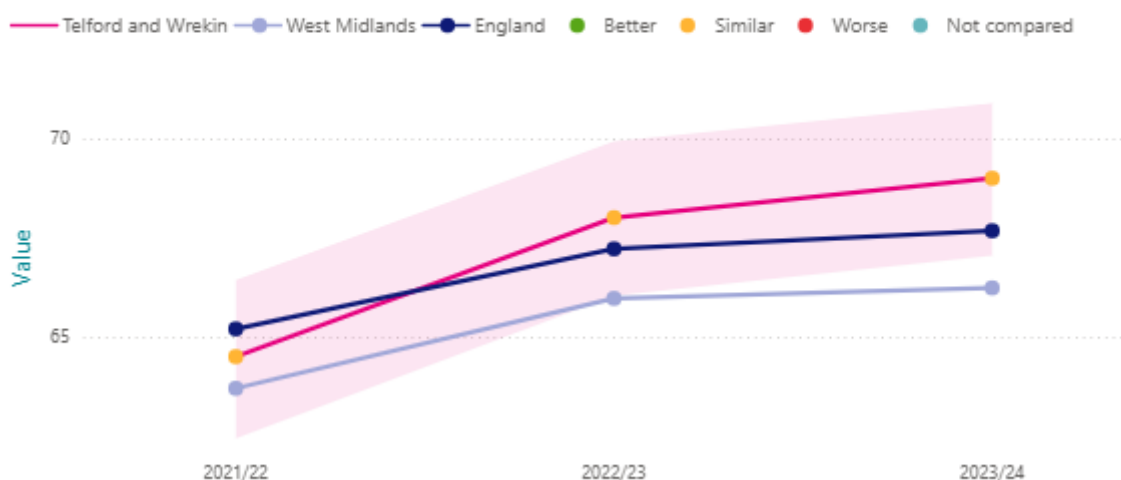

- Telford and Wrekin has lower (better) levels of air pollution than seen nationally. The concentration of fine particulate matter (PM 2.5), at 6.4, is lower than the national level of 7.8.
- The residents of the borough also have notably higher levels of access to green space than nationally, with an average population of 3,864 per park, public garden or playing field compared to a national average of 9,077 people.
- Residents of the borough have lower levels of 'active travel' than seen nationally. In 2022/23, 10.3% of adults walked for travel, worse than the national rate.

5.0 Alternative Options

- 5.1 A range of performance metrics were considered for inclusion within this paper. This paper proposes a concise set of key outcome metrics to enable the HWB to monitor delivery of its strategy. There are currently no alternative options proposed as the Board are required to have regular oversight of strategy delivery in a clear and focussed format. However, it is expected that the set of metrics will develop and grow through the course of the strategy.

Such measures would need to be considered as part of a separate report brought by the relevant service through the Council's governance structure with the relevant financial implications reported on at that stage.

9.0 Legal and HR Implications

- 9.1 The Council has statutory obligations pursuant to the Local Government and Public Involvement in Health Act 2007 (as amended) to produce a Health and Wellbeing Strategy, setting out how the assessed health needs in relation to the borough are to be met by the Council, the Integrated Care Board and NHS England.
- 9.2 The recommendations in this report and the strategy itself comply with the Council's statutory obligations.

The proposals contained in this report can be delivered using existing resources.

10.0 Ward Implications

- 10.1 This report details performance at a borough level. The JSNA highlights needs of different communities across the borough for many of the measures included within this report.

11.0 Health, Social and Economic Implications

- 11.1 The measures in the Health & Wellbeing Board performance framework reflect the health, social and economic needs of the population and the changes over time. Further information about many of these measures can be found in the JSNA.

12.0 Equality and Diversity Implications

- 12.1 The measures in the Health & Wellbeing performance framework include specific inequalities measures. The JSNA, which also contains many of these measures, also contains variables in need due to characteristics or geographic factors.
