Good afternoon Mrs Marsh,

Following on from our meeting last Friday, I have now had the opportunity to look into the couple of issues which were raised at the time of the visit.

With regard to the tree preservation order made upon the Cherry tree. At this time, it is a provisional order and you do you a period of time to lodge an objection.

The details of how to object are set out in the letter, which was sent out to you with the order. I believe you would be required to write a letter of objection to our legal and democratic services dept.

The current order will be valid for a 6 month period, if no objections are received it will be confirmed.

If a letter of objection is received, then it will go to plans board where you will have the opportunity to speak to members against the order.

You would still be able to apply to work on the tree during this time or apply to fell it. There is no cost to yourself for a tree work application.

If you do apply to fell, it would more than likely be refused by the local authority. However, you would be given the chance to appeal via the secretary of state who takes the decision out of the hands of the local authority officers.

I have spoken to the planning officer who made the decision and refused your neighbours screening, below is the refusal notice.

1. The Local Planning Authority considers that the retrospective scheme causes significant harm to the character and appearance of the application property and conservation area by virtue of its suburban design, height, materials used and prominence on the streetscene along Farm Lane. The retrospective scheme is not considered to be a traditional form of boundary treatment in this location due to the materials used. The application has also not demonstrated that there are any substantial public benefits associated with the retrospective scheme or exceptional circumstances to outweigh the harm. Therefore, the application does not comply with Policy BE1, Policy BE2, Policy BE3 and Policy BE5 of the Telford & Wrekin Local Plan 2011-2031, the Horsehay & Spring Village Conservation Area Appraisal & Management Plan and the national guidance contained within the NPPF.

It appears as though it is the conservation area legislation which has prevented the installation of the screening.

You may be able to get some advice from the planning department as to what would be acceptable as a temporary screen until the laurel hedge is established.

I hope you find this information to be of use, sorry I could not have been more help.
