

**External Walls:**

Existing rough hewn render to be repainted. White Colour. Cracks and damage to be made good. Damaged/crumbling bricks to be replaced (to match existing).

Existing woodwork/paintwork to be repainted/refurbished as required.

Existing windows to be retained (unless shown replaced) to be cleaned/refurbished as required.

New white coloured flues (to match render) as required.

Internal face of walls to be drylined with insulation/studwork/plasterboard.


**Windows & Doors:**


Existing timber doors to be refurbished. Where shown existing timber doors to be refurbished and repositioned in new openings.

Where shown existing UPVC doors and combined windows to be replaced with painted timber doors and window sets.

All existing UPVC windows to be replaced with timber, lights to match original building.

Existing timber windows to be refurbished. Where required existing window frames to remain in situ and new opening/fixing windows installed. To be in timber and to match existing.

Walls, floors and ceilings to be upgraded to meet current building control requirements for residential use.

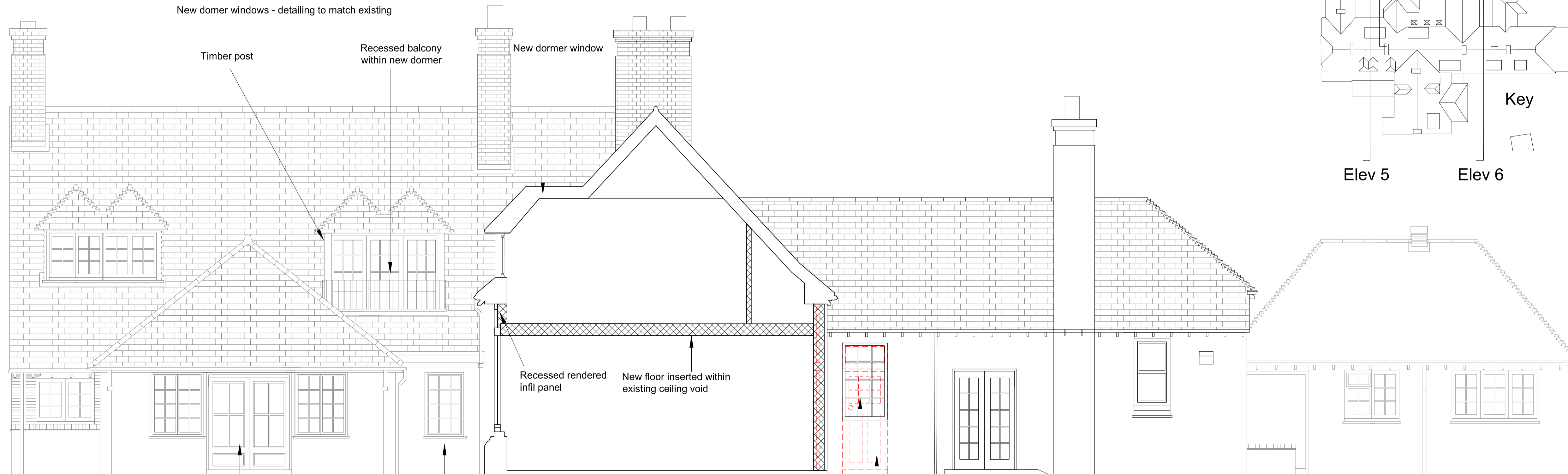

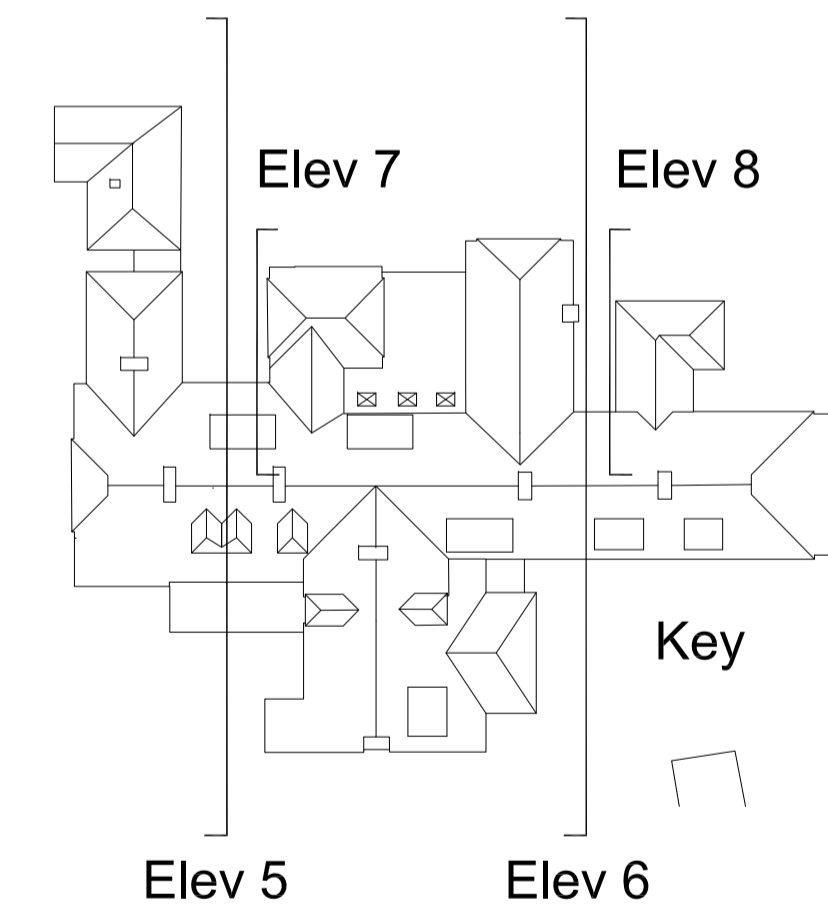
